10	A BILL to amend and reenact $\$21A-2C-2$ , $\$21A-2C-3$ and $\$21A-2C-4$ of
11	the Code of West Virginia, 1931, as amended, all relating to
12	the Military Incentive Program; and including all veterans of
13	armed conflict.
14	Be it enacted by the Legislature of West Virginia:
15	That $\$21A-2C-2$ , $\$21A-2C-3$ and $\$21A-2C-4$ of the Code of West
16	Virginia, 1931, as amended, be amended and reenacted, all to read
17	as follows:
18	ARTICLE 2C. MILITARY INCENTIVE PROGRAM.
19	§21A-2C-2. Declaration of legislative intent and purpose.
20	The Legislature of West Virginia hereby recognizes that
21	disabled veterans and economically disadvantaged veterans of the
22	Vietnam era and of the Korean conflict, members of the West
23	Virginia National Guard and the reserve forces of the United States

1 have made sacrifices which merit preferential employment treatment 2 in both the public and private sectors. Economically disadvantaged 3 and disabled veterans traditionally suffer a disproportionately 4 higher unemployment rate than that of nonveterans of similar age 5 and skills. Members of the West Virginia National Guard and 6 reserve forces of the United States who are called upon to leave 7 their jobs to perform military obligations are frequently placed in 8 conflict with their employers and as such are frequently 9 discriminated against by prospective employers. It is the intent 10 and purpose of the Legislature to encourage the employment of these 11 veterans and members of the quard and reserve forces in the private 12 sector by providing tax credits for private sector employers who 13 employ economically disadvantaged Vietnam era and Korean conflict 14 veterans, disabled veterans, unemployed members of the West 15 Virginia National Guard and unemployed members of the reserve 16 forces of the United States generally.

## 17 §21A-2C-3. Definitions.

18 For the purposes of this article:

(a) "Active duty" means full-time duty in the Armed Forces, other than duty for training in the reserves or National Guard. Any period of duty for training in the reserves or National Guard, including authorized travel, during which an individual was disabled from a disease or injury incurred or aggravated in line of

1 duty, is considered "active duty."

(b) "Economically disadvantaged" means a person who:
(1) Receives, or is a member of a family which receives, cash
welfare payments under a federal, state or local welfare program;
(2) Has, or is a member of a family which has, received a
total family income for the six months prior to application which,
in relation to family size, was not in excess of the higher of:

8 (I) The poverty level determined in accordance with criteria 9 established by the federal office of management and budget; or 10 (ii) Seventy percent of the lower living standard income 11 level;

12 (3) Is receiving food stamps pursuant to the food stamp act of 13 1977;

14 (4) Is a foster child on behalf of whom state or local 15 government payments are made; or

16 (5) Is an adult handicapped individual whose own income meets 17 the requirements of subdivisions (1) and (2) of this subsection, 18 but who is a member of a family whose income does not meet such 19 requirements.

20 (c) "Korean conflict veteran" means a person who served in the 21 armed services of the United States at least one day during the 22 period of time beginning June 27, 1950, and extending through 23 January 31, 1955.

1 (d) (c) "National guard member" means a member of any
2 component of the West Virginia National Guard.

3 (e) (d) "Reserve member" means a member of any component of 4 the reserve forces of the United States.

5 (f) (e) "Veteran" means a member of the United States Armed 6 Forces who:

7 (1) Served on active duty for a period of more than one 8 hundred eighty days and was discharged or released therefrom with 9 other than a dishonorable discharge; or

10 (2) Was discharged or released from active duty because of a 11 service-connected disability.

12 (g) "Vietnam era veteran" means a person who served in the 13 armed services of the United States at least one day during the 14 period of time beginning August 5, 1964, and extending through May 15 7, 1975.

## 16 §21A-2C-4. Tax credit; eligibility; amount.

(a) Each person, partnership or corporation which employs an economically disadvantaged Vietnam era or Korean conflict veteran or any disabled veteran, or an unemployed member of the West Virginia National Guard or a member of the reserve forces of the United States for a continuous period of one year, except as coherwise provided in this article, shall be entitled to an appropriate tax credit for each such individual so employed. In

1 the case of a person or partnership so employing such individuals, 2 the tax credit provided for in this section shall be applied 3 against the employer's personal income tax liability. In the case 4 of a corporation so employing such individuals, the tax credit 5 provided for in this section shall be applied against the 6 corporation's corporate net income tax liability. This tax credit 7 shall be nonassignable and may not exceed an employer's total tax 8 liability with respect to the specific tax against which the tax 9 credit is required to be applied.

10 (b) The amount of the tax credit allowed under subsection (a)11 of this section shall be an amount equal to the following:

12 (1) For each economically disadvantaged <del>Vietnam era or Korean</del> 13 <del>conflict</del> veteran employed as described in subsection (a), the 14 amount of the tax credit allowed shall be thirty percent of the 15 employee's wage base. For the purposes of this section, the 16 employee's wage base is the first \$5,000 in wages or compensation 17 actually paid to the employee by the employer;

18 (2) For each disabled veteran employed as described in 19 subsection (a), the amount of the tax credit allowed shall be a 20 percentage equal to the percentage of disability suffered by the 21 veteran multiplied by the employee's wage base. The employee's 22 wage base is the same as provided in subdivision (1) of this 23 subsection. The percentage of disability referred to in this

1 subdivision means the percentage of compensation for service 2 connected disability as determined by the United States Department 3 of Veterans Affairs; and

4 (3) For each member of the West Virginia National Guard or 5 member of the reserve forces of the United States employed as 6 described in subsection (a), the amount of the tax credit allowed 7 shall be twenty-five percent of the employee's wage base. For the 8 purpose of this section, the employee's wage base is the first 9 \$5,000 in wages or compensation actually paid to the employee by 10 the employer.

NOTE: The purpose of this bill is to expand the Military Incentive Program to include all economically disadvantaged veterans.
