10	A BILL to amend the Code of West Virginia, 1931, as amended, by
11	adding thereto a new article, designated $$5-30-1$, $$5-30-2$,
12	\$5-30-3, $$5-30-4$ and $$5-30-5$, all relating to state
13	recognition of Native American tribes; defining terms;
14	recognizing certain tribes by the state; establishing criteria
15	for state recognition of additional tribes; authorizing unique
16	trademarks for certain arts and crafts; prohibiting gambling;
17	and providing penalty for unauthorized use of trademark.
18	Be it enacted by the Legislature of West Virginia:
19	That the Code of West Virginia, 1931, as amended, be amended
20	by adding thereto a new article, designated $$5-30-1$, $$5-30-2$,
21	\$5-30-3, $$5-30-4$ and $$5-30-5$, all to read as follows:
22	ARTICLE 30. WEST VIRGINIA NATIVE AMERICAN TRIBES UNIQUE
23	RECOGNITION, AUTHENTICATION AND LISTING ACT.

- 1 §5-30-1. State Recognition of Native American Tribes.
- 2 (a) The Legislature of West Virginia finds that the
- 3 recognition by the state of Native American tribes is necessary to
- 4 protect and preserve the cultural heritage of certain citizens of
- 5 this state. State recognition of official tribes would permit
- 6 Native American citizens of West Virginia access to certain
- 7 educational opportunities, and certain economic development
- 8 assistance and would aid in the protection of certain unique
- 9 cultural activities.
- 10 (b) This article shall be known as the "West Virginia Native
- 11 American Tribes Unique Recognition, Authentication and Listing
- 12 Act".
- 13 (c) This article shall be liberally construed to encourage and
- 14 enhance state recognition of Native American Tribes where
- 15 recognized status is required to determine eligibility for
- 16 educational, cultural and economic development opportunities,
- 17 incentives and programs, including, but not limited to, applicable
- 18 programs, grants, awards and trademark recognition as required or
- 19 recognized pursuant to the Indian Arts and Crafts Act of 1990 and
- 20 the subsequent revisions to Public Law 101-644.
- 21 **§5-30-2**. **Definitions**.
- 22 (a) As used in this article:
- 23 (1) "Executive Director" means the executive director of the

- 1 Herbert Henderson Office of Minority Affairs as appointed by the
- 2 Governor pursuant to article twenty-nine of chapter five of this
- 3 code.
- 4 (2) "Indian" means an individual who:
- 5 (A) Is a member of an Indian tribe;
- 6 (B) Is certified as an Indian artisan by an Indian tribe; or
- 7 (C) Is a direct lineal descendant of a person listed on the
- 8 base roll of an Indian tribe, whether or not the individual
- 9 qualifies for membership in the Indian tribe; or
- 10 (D) Is a direct lineal descendant of a person listed on a
- 11 judgment fund distribution list, roll or census of Indians or other
- 12 document prepared and approved by the Secretary of the Interior or
- 13 his or her authorized representative, whether or not the judgment
- 14 fund distribution list, roll, census or document is used by an
- 15 Indian tribe to determine membership; or
- 16 (E) Is certified as a member of a recognized Indian Tribe by
- 17 an Indian Organization recognized by this state pursuant to the
- 18 provisions of this article.
- 19 (3) "Indian Organization" means the Native American Indian
- 20 Federation Incorporated, the Appalachian American Indians of West
- 21 Virginia Incorporated, or other nonprofit Native American
- 22 organization that:
- (A) (i) Is chartered as a 501(c)(3) with the state in which the

- 1 organization is headquartered; (ii) is dedicated to preserving
- 2 Native American principles, traditions, culture, history, language
- 3 and arts; (iii) performs free genealogical research to verify that
- 4 an individual meets the definition of "Indian" as defined in this
- 5 article; and (iv) retains genealogical information collected on its
- 6 members; or
- 7 (B) Is recognized by a state legislative body as an Indian
- 8 Organization or group, in which a majority of its members are
- 9 recognized as Indians, or the organization is federally recognized
- 10 as an Indian organization.
- 11 (4) "Indian Tribe", "Native American Tribe", or "Tribe" means
- 12 any Native American Indian tribe, band, nation or other organized
- 13 group or community which:
- 14 (A) Is recognized by the United States Secretary of the
- 15 Interior; or
- 16 (B) Is recognized by any state in these United States as
- 17 enacted by Legislative action; or
- 18 (C) Is recognized by this state in, or is seeking recognition
- 19 pursuant to the provisions of this article.
- 20 (5) "Office" means the Herbert Henderson Office of Minority
- 21 Affairs pursuant to article twenty-nine of chapter five of this
- 22 code.
- 23 (6) "State Recognized Tribe" or "West Virginia Recognized

- 1 Tribe" means any Native American Indian tribe, band, nation or
- 2 other organized group or community as designated by this article or
- 3 as recognized in the initial enactment of this article or as
- 4 recognized pursuant to the provisions for recognition as proscribed
- 5 by this article.
- 6 (7) "Secretary" means the West Virginia Secretary of State.
- (8) "Trademark", or "West Virginia Native American Trademark"
 8 or "Native American Trademark" means any word, name, symbol, mark
 9 or any combination thereof used by a person or tribe to identify
 10 and distinguish a unique product, service or good, made or provided
 11 exclusively in West Virginia by persons affiliated with or
 12 belonging to any recognized tribe in this state. Notwithstanding
 13 any other provisions of this code to the contrary and unless
 14 otherwise specifically implied in connection with this article, the
 15 term "trademark" does not reduce or restrict the authority of the
 16 Secretary of State to issue such trademarks and require such
 17 application and fees as required pursuant to the provisions of

18 article two, chapter forty-seven of this code.

20 (a) Upon enactment of this article the tribes and qualified 21 members of the tribes may be recognized as Native American tribes 22 of West Virginia and Native American peoples of West Virginia 23 including for, but not limited to, the purposes of:

- 1 (1) Establishing eligibility for various educational
- 2 opportunities, including, but not limited to, grants, loans and
- 3 scholarships;
- 4 (2) Establishing eligibility for various economic development
- 5 and other incentive programs including, but not limited to, grants,
- 6 loans and gifts;
- 7 (3) Establishing eligibility for the issuance and possession
- 8 of unique trademarks for certain arts and crafts; and
- 9 (4) Establishing eligibility for participation or affiliation
- 10 in any sanctioned or recognized activity including any activity
- 11 that may be established pursuant to this article.
- 12 (b) The following tribes shall be officially recognized as
- 13 Native American Tribes of West Virginia unless added to or removed
- 14 from this list pursuant to the provisions of this article:
- 15 (1) Adena;
- 16 (2) Cayuga;
- 17 (3) Cherokee;
- 18 (4) Conoy;
- 19 (5) Delaware;
- 20 (6) Iroquois, including Mingo, Oneida, Onondaga and Seneca;
- 21 (7) Ottawa;
- 22 (8) Shawnee;
- 23 (9) Sioux, including Blackfoot and Lakota;

- 1 (10) Susquehannock including Honniasont;
- 2 (11) Tutelo including Monacan and Saponi;
- 3 (12) Tuscarora;
- 4 (13) Uninh; and
- 5 (14) Wyandot.
- 6 (c) The following Indian organizations shall be officially
- 7 recognized as Native American Tribes of West Virginia:
- 8 (1) Native American Indian Federation Incorporated; and
- 9 (2) The Appalachian American Indians of West Virginia 10 Incorporated.
- 11 §5-30-4. Application for recognition of tribes.
- 12 (a) After the enactment of this article, Native American
- 13 Tribes may apply for and petition for recognition of additional
- 14 tribes as specified pursuant to this article:
- 15 (1) The burden of proof is on the petitioning group, not the 16 evaluators;
- 17 (2) The executive director may propose rules for legislative
- 18 approval in accordance with the provisions of article three,
- 19 chapter twenty-nine-a of this code for the purpose of requiring
- 20 forms and describing the process for the evaluation and approval of
- 21 Native American Tribes:
- 22 (3) The executive director shall review all requests for
- 23 recognition of Native American Tribes;

- 1 (4) The executive director shall propose state recognition of
- 2 Native American Tribes in the form of a rule, for legislative
- 3 approval in accordance with the provisions of article three,
- 4 chapter twenty-nine-a of this code;
- 5 (5) The executive director may recommend approval of a request
- 6 for the recognition of a Native American Tribe or Native American
- 7 people, if:
- 8 (A) The tribe or people are recognized by another state or by
- 9 the United States Secretary of the Interior;
- 10 (B) The groups members have retained a specific Indian
- 11 identity through time;
- 12 (C) The group demonstrates descent from a historical Indian
- 13 group that lived within West Virginia's current boundaries at the
- 14 groups first contact with Europeans; or
- 15 (D) The group traces the continued existence within West
- 16 Virginia for four generations to the present.
- 17 (6) Criteria to be used in the evaluation of a request for
- 18 recognition includes:
- 19 (A) Affidavits from elderly group members that the group has
- 20 identified internally as "Indian";
- 21 (B) Affidavits by local area residents of descendants
- 22 testifying that the group or individual members identified
- 23 themselves as "Indian";

- 1 (C) Local, state or federal records that show the group or 2 individual members identified themselves as "Indian";
- 3 (D) Accounts by anthropologists that mention or describe the 4 group or individual members as "Indian" or by the name of the group
- 5 or individuals seeking recognition;
- 6 (E) Colonial, local, state or federal records that show the 7 group, or individual members of it were identified as Indian or as 8 their ancestral tribe:
- 9 (F) Documents evident of the formation of an organization, 10 corporation, school, church or institution that identified the 11 group as Indian or by the tribal name;
- 12 (G) Historical accounts including letters, reports, diaries or 13 other documentation describing encounters with the tribe;
- 14 (H) Letters or diaries from a government official describing 15 the group as Indian or by the tribal name;
- (I) Treaties, resolutions, agreements or other governmental records or correspondence pertaining to the groups lands or activities, including any record of encroachment on the group's lands or activities;
- (J) Census records, tax records, land deeds, land patents, 21 plat books or other records mentioning the groups location, members 22 living nearby or otherwise describing community structures; and
- 23 (K) Genealogy records of any current member or living ancestor

- 1 appearing in public records as "Indian" or by group name.
- 2 (7) A petitioning group may be recognized if it has:
- 3 (A) A formally organized system of governance, with
- 4 established bylaws and with membership criteria restricting
- 5 membership to people proving genealogical descent from the historic
- 6 tribe or from a historic membership roll;
- 7 (B) A formal petition or letter of intent signed by a simple
- 8 majority of the members of the group seeking recognition; and
- 9 (C) Supporting documentation as described in this section.
- 10 (8) When the executive director approves a request to
- 11 recognize a Native American tribe, he or she shall include a
- 12 description of the application and documentation supporting the
- 13 approval in the annual report required pursuant to section one,
- 14 article twenty-six, chapter five of this code.
- 15 (9) A Native American Tribe may not be recognized until the
- 16 recognition is adopted by an Act of the Legislature or pursuant to
- 17 the provisions of this article.
- 18 §5-30-5. Prohibiting gambling activity; unauthorized use of name
- or trademark; and penalty.
- 20 (a) Nothing in this article shall be construed to imply or
- 21 permit gambling, gaming as regulated by the West Virginia Lottery
- 22 Commission pursuant to the provisions of article twenty-two,
- 23 article twenty-two-a, article twenty-two-b or article twenty-two-

- 1 c, of chapter twenty-nine of this code.
- 2 (b) No person may use a trademark as issued pursuant to this
- 3 article nor hold themselves out to be a member of a recognized
- 4 tribe in this state unless the trademark or membership is
- 5 authorized and issued pursuant to the provisions of this article.
- 6 (c) A person engaging in unauthorized use of any trademark or
- 7 the unauthorized use of the name or reference to any recognized
- 8 Native American tribe of this state, is guilty of a misdemeanor
- 9 and, upon conviction thereof, shall be fined not more than \$2,500
- 10 or confined in a county or regional jail not more than six months,
- 11 or both fined and confined.

NOTE: The purpose of this bill is to create the West Virginia Native American Tribes Unique Recognition, Authentication and Listing Act.

This article is new; therefore, strike-throughs and underscoring have been omitted.
