

# Senate Bill No. 558

(By Senators Facemire, Edgell and Blair)

A BILL finding and declaring certain claims against the state and its  
agencies to be moral obligations of the state; and directing the  
Auditor to issue warrants for the payment thereof.

*Be it enacted by the Legislature of West Virginia:*

## **CLAIMS AGAINST THE STATE.**

**§1. Finding and declaring certain claims against the  
Department of Administration/Office of Technology;  
Department of Health and Human Resources; Division  
of Corrections; Division of Highways; Division of  
Juvenile Services; Division of Motor Vehicles; Real  
Estate Commission; Regional Jail Authority; and State  
of West Virginia to be moral obligations of the state  
and directing payment thereof.**

1       The Legislature has considered the findings of fact and  
2 recommendations reported to it by the Court of Claims  
3 concerning various claims against the state and agencies  
4 thereof and in respect to each of the following claims, the  
5 Legislature adopts those findings of fact as its own and in  
6 respect of certain claims herein, the Legislature has  
7 independently made findings of fact and determinations of  
8 award and hereby declares it to be the moral obligation of the  
9 state to pay each such claim in the amount specified below  
10 and directs the Auditor to issue warrants for the payment  
11 thereof out of any fund appropriated and available for the  
12 purpose.

416       The Legislature finds that the above moral obligations  
417   and the appropriations made in satisfaction thereof shall be  
418   the full compensation for all claimants and that prior to the  
419   payments to any claimant provided in this bill, the Court of  
420   Claims shall receive a release from said claimant releasing  
421   any and all claims for moral obligations arising from the  
422   matters considered by the Legislature in the finding of the  
423   moral obligations and the making of the appropriations for  
424   said claimant. The Court of Claims shall deliver all releases  
425   obtained from claimants to the department against which the  
426   claim was allowed.

(NOTE: The purpose of this bill is for the Legislature to find and declare the existence of a moral obligation to pay, with public moneys, each of the claims herein against specified state agencies and the State of West Virginia, by the named claimants, payable from the specified funds, and in the amounts of the awards made.

A second and separate bill (either supplementary appropriation bill or a section of the budget bill) will actually appropriate the moneys herein awarded and permit payment in current fiscal year 2013 and through 2014.

The totals, as to type of funds and amounts of awards in the bill, are:

- (1) General Revenue Funds of \$2,797,841.21
- (2) Special Revenue Funds of \$ 351,397.06
- (3) State Road Funds of     \$ 611,754.16)
