Senate Bill No. 350

(By Senators Miller, Stollings, Snyder, Plymale, Laird, D. Hall, Unger and Beach)

[Introduced January 14, 2014; referred to the Committee on Agriculture and Rural Development.]

A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section, designated §19-1-11, relating to the Rural Rehabilitation Loan Program; requiring annual reporting; and authorizing rulemaking.

Be it enacted by the Legislature of West Virginia:

That the Code of West Virginia, 1931, as amended, be amended by adding thereto a new section, designated §19-1-11, to read as follows:

ARTICLE 1. Department of Agriculture.

§19-1-11. Rural Rehabilitation Loan Program.

- 1 (a) The Rural Rehabilitation Loan Program is an
- 2 important tool for the Commissioner of Agriculture to

- 3 promote investment in the agricultural industry in the state.
- 4 Rules are needed for the loan program to remain viable.
- 5 (b) The commissioner shall propose rules for legislative
- 6 approval in accordance with article three, chapter
- 7 twenty-nine-a of this code. The rules shall, at a minimum:
- 8 (1) Establish minimum requirements and qualifications
- 9 for the loan committee, including the addition of public
- 10 members who have agricultural or business loan experience;
- 11 (2) Prohibit department employees and loan committee
- 12 members, and their immediate family members, from
- 13 receiving program loans;
- 14 (3) Establish minimum financial requirements for
- 15 receiving a program loan;
- 16 (4) Require loans to be used for agricultural purposes;
- 17 (5) Require collateral sufficient to secure the loan;
- 18 (6) Establish policies for the application, applicable
- 19 interest rates, delinquencies, refinancing, collection
- 20 proceedings, collateral requirements and other aspects of the
- 21 loan program;

- 22 (7) Require the department to advertise the loan program
- 23 to the public, including information on the department's
- 24 website and in the department's market bulletin; and
- 25 (8) Consider transferring the servicing of program loans
- 26 to the State Treasurer's Office.
- (c) The commissioner shall file an annual report to the
- 28 Joint Committee on Government and Finance regarding the
- 29 loan program, including information about the loans
- 30 awarded, loans repaid, loans outstanding, interest rates,
- 31 delinquency and collections, and other pertinent data.

(NOTE: The purpose of this bill is to require the Commissioner of Agriculture to propose rules for the West Virginia Department of Agriculture Rural Rehabilitation Loan Program.

This section is new; therefore, strike-throughs and underscoring has been omitted.)
