AN ACT to amend and reenact §18B-1B-2 of the Code of West Virginia, 1931, as amended; to amend and reenact §18B-2A-1 of said code; and to amend and reenact §18B-2B-4 of said code, all relating to higher education; appointment of members to the Higher Education Policy Commission; appointment of members to the institutional boards of Governors; and appointment of members to the West Virginia Council for Community and Technical College Education.

Be it enacted by the Legislature of West Virginia:

That §18B-1B-2 of the Code of West Virginia, 1931, as amended, be amended and reenacted; that §18B-2A-1 of said code be amended and reenacted; and that §18B-2B-4 of said code be amended and reenacted, all to read as follows:

## ARTICLE 1B. HIGHER EDUCATION POLICY COMMISSION.

§18B-1B-2. Composition of commission; terms and qualifications of members; vacancies; eligibility for reappointment; oath of office; removal from office.

- 1 (a) The commission is comprised of ten members, all of 2 whom are entitled to vote. The membership of the 3 commission is as follows:
- 4 (1) The Secretary of Education and the Arts, ex officio;
- 5 (2) The State Superintendent of Schools, ex officio;
- 6 (3) The chair of the West Virginia Council for 7 Community and Technical College Education, ex officio; and
- 8 (4) Seven at-large members who are citizens of the state, 9 appointed by the Governor, by and with the advice and 10 consent of the Senate: Provided, That prior to appointment, 11 the Governor shall interview each candidate to assure that the 12 person selected understands and is committed to achieving 13 the goals and objectives as set forth in the institutional 14 compacts and in section one-a, article one of this chapter. 15 The Governor shall invite the President of the Senate, the 16 Speaker of the House of Delegates, the chairs of the Senate and House of Delegates committees on finance and education 17 18 and such other legislative leaders as the Governor may 19 determine to participate in interviewing potential candidates.
- 20 (b) Each of the at-large members appointed by the 21 Governor shall represent the public interest and shall be 22 committed to the legislative intent and goals set forth in state 23 law and policy.
  - (c) The Governor may not appoint any person to be a member of the commission who is an officer, employee or member of the council or an advisory board of any state college or university; an officer or member of any political party executive committee; the holder of any other public office or public employment under the government of this state or any of its political subdivisions; an appointee or

- 31 employee of any governing board; or an immediate family
- 32 member of any employee under the jurisdiction of the
- 33 commission, the council or any governing board.
- 34 (d) Of the seven at-large members appointed by the
- 35 Governor:
- 36 (1) No more than four may belong to the same political
- 37 party;
- 38 (2) At least two shall be appointed from each
- 39 congressional district; and
- 40 (3) No more than one member may serve from the same
- 41 county.
- 42 (e) The at-large members appointed by the Governor
- 43 serve overlapping terms of four years.
- 44 (f) The Governor shall appoint a member to fill any
- 45 vacancy among the seven at-large members, by and with the
- 46 advice and consent of the Senate. Any member appointed to
- 47 fill a vacancy serves for the remainder of the unexpired term.
- 48 The Governor shall fill the vacancy within sixty days of the
- 49 occurrence of the vacancy.
- 50 (g) An at-large member appointed by the Governor may
- 51 not serve more than two consecutive terms. If the Governor
- 52 intends to reappoint an at-large member for a second term,
- 53 the Governor shall do so within thirty days prior to expiration
- 54 of the term. If the Governor does not reappoint within the
- 55 thirty-day period, the term is deemed expired, effective on the
- scheduled expiration date.
- (h) Upon expiration of an at-large member's term, the
- 58 Governor shall appoint a successor within sixty days of the

- 59 end of term. An at-large member whose term has expired
- 60 may not serve more than sixty days following expiration of
- 61 the term.
- 62 (i) Before exercising any authority or performing any
- duties as a member of the commission, each member shall
- qualify as such by taking and subscribing to the oath of office
- 65 prescribed by section five, article IV of the Constitution of
- West Virginia and the certificate thereof shall be filed with
- 67 the Secretary of State.
- (j) A member of the commission appointed by the
- 69 Governor may not be removed from office by the Governor
- 70 except for official misconduct, incompetence, neglect of duty
- or gross immorality and then only in the manner prescribed
- 72 by law for the removal of the state elective officers by the
- 73 Governor.

#### ARTICLE 2A. INSTITUTIONAL BOARDS OF GOVERNORS.

# §18B-2A-1. Findings; composition of boards; terms and qualifications of members; vacancies; eligibility for reappointment.

- 1 (a) Findings. The Legislature finds that the State of
- 2 West Virginia is served best when the membership of each
- 3 governing board includes the following:
- 4 (1) The academic expertise and institutional experience
- 5 of faculty members and a student of the institution governed
- 6 by the board;
- 7 (2) The technical or professional expertise and
- 8 institutional experience of a classified employee of the
- 9 institution governed by the board;

- 10 (3) An awareness and understanding of the issues facing 11 the institution governed by the board; and
- 12 (4) The diverse perspectives that arise from a membership 13 that is balanced in terms of gender and varied in terms of race 14 and ethnic heritage.
- 15 (b) Boards of Governors continued. A Board of
- 16 Governors is continued at each of the following institutions:
- 17 Bluefield State College, Blue Ridge Community and
- 18 Technical College, BridgeValley Community and Technical
- 19 College, Concord University, Eastern West Virginia
- 20 Community and Technical College, Fairmont State
- 21 University, Glenville State College, Mountwest Community
- 22 and Technical College, Marshall University, New River
- 23 Community and Technical College, Pierpont Community and
- 24 Technical College, Shepherd University, Southern West
- 25 Virginia Community and Technical College, West Liberty
- 26 University, West Virginia Northern Community and
- 27 Technical College, West Virginia School of Osteopathic
- 28 Medicine, West Virginia State University, West Virginia
- 29 University and West Virginia University at Parkersburg.

#### 30 (c) Board membership. –

- 31 (1) An appointment to fill a vacancy on the board or
- 32 reappointment of a member who is eligible to serve an
- additional term is made in accordance with the provisions of
- 34 this section.
- 35 (2) The Board of Governors for Marshall University
- 36 consists of sixteen persons. The Board of Governors for
- 37 West Virginia University consists of seventeen persons. The
- 38 boards of governors of the other state institutions of higher
- 39 education consist of twelve persons.

- 40 (3) Each board of governors includes the following 41 members:
- 42 (A) A full-time member of the faculty with the rank of
- 43 instructor or above duly elected by the faculty of the
- 44 respective institution;
- 45 (B) A member of the student body in good academic
- standing, enrolled for college credit work and duly elected by
- 47 the student body of the respective institution; and
- 48 (C) A member from the institutional classified employees
- 49 duly elected by the classified employees of the respective
- 50 institution;
- 51 (4) For the Board of Governors at Marshall University,
- 52 thirteen lay members appointed by the Governor, by and with
- 53 the advice and consent of the Senate, pursuant to this section;
- 54 (5) For the Board of Governors at West Virginia
- 55 University, twelve lay members appointed by the Governor,
- by and with the advice and consent of the Senate, pursuant to
- 57 this section, and additionally:
- 58 (A) The Chairperson of the Board of Visitors of West
- 59 Virginia University Institute of Technology;
- 60 (B) A full-time faculty member representing the
- 61 extension service at the institution or a full-time faculty
- 62 member representing the health sciences, selected by the
- 63 faculty senate.
- 64 (6) For each board of governors of the other state
- 65 institutions of higher education, nine lay members appointed
- by the Governor, by and with the advice and consent of the
- 67 Senate, pursuant to this section.

- 68 (A) Of the nine members appointed by the Governor, no 69 more than five may be of the same political party. Of the 70 thirteen members appointed by the Governor to the governing board of Marshall University, no more than eight may be of 71 the same political party. Of the twelve members appointed 72 73 by the Governor to the governing board of West Virginia 74 University, no more than seven may be of the same political 75 party.
- (B) Of the nine members appointed by the Governor, at least five shall be residents of the state. Of the thirteen members appointed by the Governor to the governing board of Marshall University, at least eight shall be residents of the state. Of the twelve members appointed by the Governor to the governing board of West Virginia University, at least seven shall be residents of the state.
- 83 (7) In making lay appointments, the Governor shall 84 consider the institutional mission and membership 85 characteristics including the following:
- 86 (A) The need for individual skills, knowledge and 87 experience relevant to governing the institution;
- 88 (B) The need for awareness and understanding of 89 institutional problems and priorities, including those related 90 to research, teaching and outreach;
- 91 (C) The value of gender, racial and ethnic diversity; and
- 92 (D) The value of achieving balance in gender and 93 diversity in the racial and ethnic characteristics of the lay 94 membership of each board.
- 95 (d) Board member terms. –

- 96 (1) The student member serves for a term of one year. 97 Each term begins on July 1.
- 98 (2) The faculty member serves for a term of two years. 99 Each term begins on July 1. Faculty members are eligible to 100 succeed themselves for three additional terms, not to exceed 101 a total of eight consecutive years.
- 102 (3) The member representing classified employees serves 103 for a term of two years. Each term begins on July 1. 104 Members representing classified employees are eligible to 105 succeed themselves for three additional terms, not to exceed 106 a total of eight consecutive years.
  - (4) The appointed lay citizen members serve terms of four years each and are eligible to succeed themselves for no more than one additional term, except that citizen members who are appointed to fill unexpired terms are eligible to succeed themselves for two full terms after completing an unexpired term. If the Governor intends to reappoint a lay citizen member for a second term, the Governor shall do so within thirty days prior to expiration of the term. If the Governor does not reappoint within the thirty-day period, the term is deemed expired, effective on the scheduled expiration date.
- 118 (5) A vacancy in an unexpired term of a member shall be 119 filled for the unexpired term within sixty days of the 120 occurrence of the vacancy in the same manner as the original 121 appointment or election. Except in the case of a vacancy, all elections are held and all appointments are made no later than 122 123 June 30 preceding the commencement of the term. A 124 member whose term has expired may not serve more than sixty days following expiration of the term. Each board of 125 126 governors shall elect one of its appointed lay members to be

- chairperson in June of each year. A member may not serve as chairperson for more than four consecutive years.
- 129 (6) The appointed members of the boards of governors 130 serve staggered terms of up to four years.
- 131 (e) Board member eligibility, expenses. –

- 132 (1) A person is ineligible for appointment to membership 133 on a board of governors of a state institution of higher 134 education under the following conditions:
  - (A) For a baccalaureate institution or university, a person is ineligible for appointment who is an officer, employee or member of any other board of governors; an employee of any institution of higher education; an officer or member of any political party executive committee; the holder of any other public office or public employment under the government of this state or any of its political subdivisions; an employee of any affiliated research corporation created pursuant to article twelve of this chapter; an employee of any affiliated foundation organized and operated in support of one or more state institutions of higher education; or a member of the council or commission. This subsection does not prevent the representative from the faculty, classified employees, students or the superintendent of a county board of education from being members of the governing boards.
  - (B) For a community and technical college, a person is ineligible for appointment who is an officer, employee or member of any other board of governors; a member of a board of visitors of any public institution of higher education; an employee of any institution of higher education; an officer or member of any political party executive committee; the holder of any other public office, other than an elected county office, or public employment, other than employment by the

- county board of education, under the government of this state 158 159 or any of its political subdivisions; an employee of any 160 affiliated research corporation created pursuant to article twelve of this chapter; an employee of any affiliated 161 foundation organized and operated in support of one or more 162 state institutions of higher education; or a member of the 163 164 council or commission. This subsection does not prevent the representative from the faculty, classified employees or 165 166 students from being members of the governing boards.
- (2) Before exercising any authority or performing any duties as a member of a governing board, each member shall qualify as such by taking and subscribing to the oath of office prescribed by section five, article IV of the Constitution of West Virginia and the certificate thereof shall be filed with the Secretary of State.
- 173 (3) A member of a governing board appointed by the
  174 Governor may not be removed from office by the Governor
  175 except for official misconduct, incompetence, neglect of duty
  176 or gross immorality and then only in the manner prescribed
  177 by law for the removal of the state elective officers by the
  178 Governor.
  - (4) The members of the board of governors serve without compensation, but are reimbursed for all reasonable and necessary expenses actually incurred in the performance of official duties under this article upon presentation of an itemized sworn statement of expenses.
  - (5) The president of the institution shall make available resources of the institution for conducting the business of its board of governors. All expenses incurred by the board of governors and the institution under this section are paid from funds allocated to the institution for that purpose.

# ARTICLE 2B. WEST VIRGINIA COUNCIL FOR COMMUNITY AND TECHNICAL COLLEGE EDUCATION.

#### §18B-2B-4. Appointment, composition and terms of council.

- 1 (a) The council is comprised of thirteen members selected 2 as follows:
- 3 (1) Eight members appointed by the Governor, with the 4 advice and consent of the Senate as follows:
- 5 (A) One member shall be appointed from each 6 community and technical college consortia district as
- 7 established in this article.

- 8 (B) Prior to appointment, the Governor shall interview
  - each candidate to assure that the person selected understands
- 10 and is committed to achieving the goals and objectives as set
- 11 forth in the institutional compacts and in section one-a, article
- 12 one of this chapter. The Governor shall invite the President
- 13 of the Senate, the Speaker of the House of Delegates, the
- chairs of the Senate and House of Delegates committees on finance and education and such other legislative leaders as
- 16 the Governor may determine to participate in interviewing
- 17 potential candidates.
- 18 (2) The Chairperson of the West Virginia Workforce
- 19 Investment Council:
- 20 (3) The Executive Director of the West Virginia
- 21 Development Office, or designee;
- 22 (4) The President of the West Virginia AFL-CIO, or a
- 23 designee;

- 24 (5) The Chair of the Higher Education Policy
- 25 Commission who serves as an ex officio, nonvoting member
- of the council; and
- 27 (6) The Assistant Superintendent for Technical and Adult
- 28 Education of the State Department of Education who serves
- as an ex officio, nonvoting member of the council;
- 30 (b) Any appointed member shall be a citizen of the state, 31 shall represent the public interest and shall understand and be committed to the legislative intent and achieving the goals 32 33 and objectives set forth in section one-a, article one of this chapter, the essential conditions set forth in article three-c of 34 35 this chapter, and the goals for secondary and post-secondary 36 vocational-technical- occupational and adult basic education 37 in the state. Any appointed member shall represent the 38 interests of the business, labor and employer communities 39 and demonstrate knowledge of the education needs of the 40 various regions, attainment levels and age groups within the
- 42 (c) The Governor may not appoint any person to be a member of the council who is an officer, employee or 43 44 member of an advisory board of any state college or university, the holder of any other public office or public 45 46 employment under the government of this state or any of its 47 political subdivisions, an appointee or employee of any 48 governing board or an immediate family member of any 49 employee under the jurisdiction of the commission or any 50 governing board. An individual may not serve on the council 51 who is engaged in providing, or employed by a person or 52 company whose primary function is to provide, workforce 53 development services and activities.
- 54 (d) Members of the council serve for staggered terms of 55 four years.

- (e) A member appointed by the Governor may not serve more than two consecutive terms. If the Governor intends to reappoint a member for a second term, the Governor shall do so within thirty days prior to expiration of the term. If the Governor does not reappoint within the thirty-day period, the term is deemed expired, effective on the scheduled expiration date.
- 63 (f) Upon expiration of an appointed member's term, the 64 Governor shall appoint a successor within sixty days of the 65 end of the term. An appointed member whose term has 66 expired may not serve more than sixty days following 67 expiration of the term.
  - (g) The Governor shall appoint a member to fill any vacancy among the eight appointed members, by and with the advice and consent of the Senate. Any member appointed to fill a vacancy serves for the remainder of the unexpired term. The Governor shall fill the vacancy within sixty days of the occurrence of the vacancy.
