| 20 | §49-2-8. Task Force on Prevention of Sexual Abuse of Children. |
| 21 | (a) This section may be referred to as "Erin Merryn's Law". |
| 22 | (b) The Task Force on Prevention of Sexual Abuse of Children is established. The task |
| 23 | force consists of the following members: |

1 presiding officers. Subsequent meetings shall be at the call of the presiding officer.

2 (e) The task force shall make recommendations for decreasing incidence of sexual abuse

3 of children in West Virginia. In making those recommendations, the task force shall:

- 4 (1) Gather information regarding sexual abuse of children throughout the state;
- 5 (2) Receive related reports and testimony from individuals, state and local agencies,
- 6 community-based organizations, and other public and private organizations;
- 7 (3) Create goals for state education policy that would prevent sexual abuse of children;
- 8 (4) Create goals for other areas of state policy that would prevent sexual abuse of
- 9 children; and

10 (5) Submit a report with its recommendations to the Governor and the Legislature.

11 (f) The recommendations may include proposals for specific statutory changes and

12 methods to foster cooperation among state agencies and between the state and local governments.

- 13 The task force shall consult with employees of the Bureau for Children and Family Services, the
- 14 Division of Justice and Community Services, the West Virginia State Police, the State Board of
- 15 Education, and any other state agency or department as necessary to accomplish its
- 16 responsibilities under this section.
- 17 (g) Task force members serve without compensation and do not receive expense
- 18 reimbursement."
