10 A BILL expiring funds to the unappropriated surplus balance in the State Fund, General Revenue,
11 for the fiscal year ending June 30, 2015, in the amount of \$315,496.80 from the Attorney
12 General, fund 0150, fiscal year 2013, organization 1500, appropriation 72500, and in the
13 amount of \$210,268 from the Attorney General, fund 0150, fiscal year 2013, organization
14 1500, appropriation 77900, and in the amount of \$774,644.65 from the Attorney General,
15 fund 0150, fiscal year 2014, organization 1500, appropriation 26000, and in the amount of
16 \$1,000,000 from the Auditor's Office - Purchasing Card Administration Fund, fund 1234,
17 fiscal year 2015, organization 1200, and in the amount of \$3,410,629 from the Treasurer's
18 Office - Flood Insurance Tax Fund, fund 1343, fiscal year 2015, organization 1300, and in
19 the amount of \$750,000 from the Department of Agriculture - Agriculture Fees Fund, fund
20 1401, fiscal year 2015, organization 1400, and in the amount of \$700,000 from the Attorney
21 General - Antitrust Enforcement Fund, fund 1507, fiscal year 2015, organization 1500, and
22 in the amount of \$750,000 from the Secretary of State - General Administrative Fees
23 Account, fund 1617, fiscal year 2015, organization 1600.

1 WHEREAS, the Legislature finds that the account balance in the Attorney General, fund 0150,
2 fiscal year 2013, organization 1500, appropriation 72500, in the Attorney General, fund 0150, fiscal
3 year 2013, organization 1500, appropriation 77900, in the Attorney General, fund 0150, fiscal year
4 2014, organization 1500, appropriation 26000, in the Auditor's Office - Purchasing Card
5 Administration Fund, fund 1234, fiscal year 2015, organization 1200, in the Treasurer's Office -
6 Flood Insurance Tax Fund, fund 1343, fiscal year 2015, organization 1300, in the Department of
7 Agriculture - Agriculture Fees Fund, fund 1401, fiscal year 2015, organization 1400, in the Attorney
8 General - Antitrust Enforcement Fund, fund 1507, fiscal year 2015, organization 1500, and in the
9 Secretary of State - General Administrative Fees Account, fund 1617, fiscal year 2015, organization
10 1600 exceeds that which is necessary for the purpose for which the accounts were established;
11 therefore

12 *Be it enacted by the Legislature of West Virginia:*

13 That the balance of the funds available for expenditure in the fiscal year ending June 30,
14 2015, in the Attorney General, fund 0150, fiscal year 2013, organization 1500, appropriation 72500,
15 be decreased by expiring the amount of \$315,496.80, and in the Attorney General, fund 0150, fiscal
16 year 2013, organization 1500, appropriation 77900, be decreased by expiring the amount of
17 \$210,268, and in the Attorney General, fund 0150, fiscal year 2014, organization 1500, appropriation
18 26000, be decreased by expiring the amount of \$774,644.65, and in the Auditor's Office - Purchasing
19 Card Administration Fund, fund 1234, fiscal year 2015, organization 1200, be decreased by expiring
20 the amount of \$1,000,000, and in the Treasurer's Office - Flood Insurance Tax Fund, fund 1343,
21 fiscal year 2015, organization 1300, be decreased by expiring the amount of \$3,410,629, and in the
22 Department of Agriculture - Agriculture Fees Fund, fund 1401, fiscal year 2015, organization 1400,
23 be decreased by expiring the amount of \$750,000, and in the Attorney General - Antitrust

1 Enforcement Fund, fund 1507, fiscal year 2015, organization 1500, be decreased by expiring the
2 amount of \$700,000, and in the Secretary of State - General Administrative Fees Account, fund
3 1617, fiscal year 2015, organization 1600, in the amount of \$750,000, all to the unappropriated
4 surplus balance of the State Fund, General Revenue, to be available for appropriation during the
5 fiscal year ending June 30, 2015.

6 The purpose of this supplemental appropriation bill is to expire funds from the aforesaid
7 accounts to be available for appropriation during the fiscal year 2015.
