5	(3) Now, therefore, the Legislature joins the federal government and other states around the
6	nation in passing legislation in order to combat human trafficking and protect the victims.

- 9 §15-14-5. Display of Public-Awareness Poster; Penalty for Failure to Display.
- 10 (a) The Division of Highways shall display a public-awareness poster that contains the
- 11 National Human Trafficking Resource Center hotline information in every rest area and welcome
- 12 center in the state which is open to the public.
- 13 (b) An employer shall display the public-awareness poster described in subsection (a) in a
- 4 place that is clearly conspicuous and visible to employees and the public at each of the following
- 15 locations in this state at which the employer has employees:
- 16 (1) A strip club or other sexually-oriented business;
- 17 (2) A business entity that has been found to be in violation of section five, article eight,

- 20 or minors where two or more persons are trafficked within any one year period the commission of

- 1 document or other government-issued identification document, including a document issued by a

- 14 (10) "Victim" means an individual who is subjected to human trafficking or to conduct that
- 15 would have constituted human trafficking had this section been in effect when the conduct occurred,
- 16 regardless of whether a perpetrator is identified, apprehended, prosecuted, or convicted.
- 17 (4) "Labor trafficking" means the promotion, recruitment, transportation, transfer, harboring,
- 18 enticement, provision, obtaining or receipt of a person by any means, whether a United States citizen
- 19 or foreign national, for the purpose of:
- 20 (A) Debt bondage or forced labor or services; or
- 21 (B) Slavery or practices similar to slavery.
- 22 (5) "Sex trafficking of minors" means the promotion, recruitment, transportation, transfer,

- 1 harboring, enticement, provision, obtaining or receipt of a person under the age of eighteen by any
- 2 means, whether a United States citizen or foreign national, for the purpose of causing the minor to
- 3 engage in sexual acts, or in sexual conduct violating the provisions of subsection (b), section five,
- 4 article eight of this chapter or article eight-c of this chapter.
- 5 (6) "Sex trafficking of adults" means the promotion, recruitment, transportation, transfer,
- 6 harboring, enticement, provision, obtaining, receipt of a person eighteen years of age or older,
- 7 whether a United States citizen or foreign national for the purposes of engaging in violations of
- 8 subsection (b), section five, article eight of this chapter by means of force, threat, coercion,
- 9 deception, abuse or threatened abuse of the legal process, or any scheme, plan, pattern, or other
- 10 action intended to cause a person to believe that, if the person did not engage in a violation of
- 11 subsection (b), section five, article eight of this chapter, that person or another person would suffer

- 13 (b) A person commits the offense of human trafficking if the person:
- 14 (1) Knowingly recruits, transports, transfers, harbors, receives, provides, obtains, isolates,
- 15 maintains, or entices an individual in furtherance of forced labor or to coerce an individual to engage
- 16 in commercial sexual activity.
- 17 (2) Knowingly uses coercion to compel an individual to provide labor or services, except
- 18 when such conduct is permissible under federal law or state law.
- 19 (3) Knowingly maintains or makes available a minor for the purpose of engaging the minor
- 20 in commercial sexual activity; or
- 21 (4) Uses coercion or deception to compel an adult to engage in commercial sexual activity.
- 22 (c) A business entity may be prosecuted for human trafficking under this section if:

1 (1) The entity knowingly engaged in conduct that constitutes human trafficking; or 2 (2) An employee or agent of the entity engaged in conduct that constitutes human trafficking and the commission of the offense was part of a pattern of illegal activity under this section for the benefit of the entity, which the entity knew was occurring and failed to take effective action to stop. 5 (b)(d) Any person who knowingly and willfully engages in human trafficking is guilty of a felony and, upon conviction shall be incarcerated in a state correctional facility for an indeterminate sentence of not less than three nor more than fifteen years or fined not more than \$200,000, or both. Any business entity that engages in human trafficking may be fined not more than \$500,000 for each offense, be required to disgorge profit from activity in violation of this section pursuant to section 10 five, article thirteen of this chapter, and be debarred from state and local government contracts. 11 (e) Any person who is a victim of human trafficking may bring a civil action in circuit court. The court may award actual damages, compensatory damages, punitive damages, restitution, injunctive relief and any other appropriate relief. A prevailing plaintiff is also entitled to attorney's fees and costs. - 9 conspirator is a party to the communication to be intercepted.
