MISCELLANEOUS PROVISIONS. 18 §60-6-7. Specific acts forbidden; indictment. 19 A person shall may not: 20 (1) Manufacture or sell in this state without a license any alcoholic liquor except as permitted by this article: *Provided*, That this prohibition does not apply to a valid nonprofit organization 22 hosting a fundraising event in connection with a reception, dinner or other function where food or 23 a meal and alcoholic beverages, including nonintoxicating beer, wine or liquor are served, without

- 1 charge to donors who are making a tax deductible contribution, on premises not licensed by the West
- 2 <u>Virginia Alcoholic Beverage Control Authority: Provided, however, That for purposes of such an</u>
- 3 event a valid nonprofit organization is exempt from any licensing requirements of the West Virginia
- 4 Alcoholic Beverage Control Authority;
- 5 (2) Aid or abet in the manufacture or sale of alcoholic liquor without a license except as 6 permitted by this article;
- 7 (3) Sell without a license any alcoholic liquor other than permitted by this article;
- 8 (4) Adulterate any alcoholic liquor by the addition of any drug, methyl alcohol, crude,
- 9 unrectified or impure form of ethyl alcohol, or other foreign or deleterious substance or liquid;
- 10 (5) Refill, with alcoholic liquor, any bottle or other container in which alcoholic liquor has
 11 been sold at retail in this state;
- 12 (6) Advertise any alcoholic liquor in this state except in accordance with the rules and
- 13 regulations of the commissioner; or
- 14 (7) Distribute, deal in, process, or use crowns, stamps or seals required under the authority
- 15 of this chapter, except in accordance with the rules and regulations prescribed by the commissioner.
- A person who violates any provision of this section shall be guilty of a misdemeanor and,
- 17 upon conviction shall be fined not less than \$50 nor more than \$500, or confined in jail not less than
- 18 thirty days nor more than one year or both such fine and imprisonment, for the first offense. Upon
- 19 conviction of a second or subsequent offense, the court may in its discretion impose a penalty of
- 20 confinement in the penitentiary a state correctional facility for a period not to exceed three years.
- 21 An indictment for any first violation of subdivisions (1), (2) and (3) of this section, or any
- 22 of them, shall be sufficient if in form or effect as follows:

8	Any indictment under this section shall otherwise be in conformity with section one, article
9	nine, chapter sixty-two of the code.

NOTE: The purpose of this bill is to exempt valid nonprofit organizations from licensing requirements of the West Virginia Alcoholic Beverage Control Authority during certain events.
