Senate Bill No. 578

[Originating in the Committee on the Judiciary;
reported February 27, 2015.]

A BILL to amend and reenact §23-4-8d of the Code of West Virginia, 1931, as amended; and to amend and reenact §23-5-7 of said code, all relating to authorization of compromise and settlement of occupational disease claims; permitting final settlement of medical benefits for nonorthopedic occupational disease claims; and requiring claimant be represented by legal counsel in these claims.

Be it enacted by the Legislature of West Virginia:

That §23-4-8d of the Code of West Virginia, 1931, as amended, be amended and reenacted; and that §23-5-7 of said code be amended and reenacted, all to read as follows:

ARTICLE 4. DISABILITY AND DEATH BENEFITS.

§23-4-8d. Occupational pneumoconiosis claims never closed for medical benefits with exception of settled claims.

1 Notwithstanding the provisions of subdivision (4), subsection (a), section sixteen of this
2 article, with the exception of claims settled pursuant to article five, section seven of this chapter, a
3 request for medical services, durable medical goods or other medical supplies in an occupational

1 pneumoconiosis claim may be made at any time.

2 **ARTICLE 5. REVIEW.**

3 **§23-5-7. Compromise and settlement.**

4 (a) With the exception of medical benefits for nonorthopedic occupational disease claims,
5 ~~the~~ The claimant, the employer and the Workers' Compensation Commission, the successor to the
6 commission, other private insurance carriers and self-insured employers, whichever is applicable,
7 may negotiate a final settlement of any and all issues in a claim wherever the claim is in the
8 administrative or appellate processes: Provided, That in the settlement of medical benefits for
9 nonorthopedic occupational disease claims, the claimant shall be represented by legal counsel. If the
10 employer is not active in the claim, the commission, the successor to the commission, other private
11 insurance carriers and self-insured employers, whichever is applicable, may negotiate a final
12 settlement of any and all issues in a claim except for medical benefits for nonorthopedic occupational
13 ~~disease claims~~ with the claimant and said the settlement shall be made a part of the claim record.
14 Except in cases of fraud, no issue that is the subject of an approved settlement agreement may be
15 reopened by any party, including the commission, the successor to the commission, other private
16 insurance carriers and self-insured employers, whichever is applicable. Any settlement agreement
17 may provide for a lump-sum payment or a structured payment plan, or any combination thereof, or
18 any other basis as the parties may agree. If a self-insured employer later fails to make the
19 agreed-upon payment, the commission shall assume the obligation to make the payments and shall
20 recover the amounts paid or to be paid from the self-insurer employer and its sureties or guarantors
21 or both as provided in sections five and five-a, article two of this chapter.

1 **(b)** Each settlement agreement shall provide the toll-free number of the West Virginia State
2 Bar Association and shall provide the injured worker with five business days to revoke the executed
3 agreement. The Insurance Commissioner may void settlement agreements entered into by an
4 unrepresented injured worker which are determined to be unconscionable pursuant to criteria
5 established by rule of the commissioner.

6 **(c)** The amendments to this section enacted during the regular session of the Legislature in
7 the year ~~one thousand nine hundred ninety-nine~~ shall 2015 apply to all settlement agreements
8 executed after the effective date.
