10	A BILL to amend and reenact §20-7-1a and §20-7-1c of the Code of West Virginia, 1931, as	
11	amended, all relating to providing increase in compensation for natural resources police	
12	officers.	
13	Be it enacted by the Legislature of West Virginia:	
14	That §20-7-1a and §20-7-1c of the Code of West Virginia, 1931, as amended, be amended	
15	and reenacted, all to read as follows:	
16	ARTICLE 7. LAW ENFORCEMENT, MOTORBOATING, LITTER.	
17	§20-7-1a. Natural resources police officer salary increase based on length of service.	
18	(a) Effective July 1, 2002, each natural resources police officer shall receive and be entitled	
19	to an increase in salary based on length of service, including that heretofore and hereafter served as	
20	a natural resources police officer as follows: For five years of service with the division, a natural	
21	resources police officer shall receive a salary increase of \$600 per year payable during his or her next	

- 1 three years of service and a like increase at three-year intervals thereafter, with these increases to be
- 2 cumulative. Each natural resources police officer whose salary is fixed and specified pursuant to
- 3 section one-c of this article shall receive, and is entitled to, an increase in salary over that set forth
- 4 <u>in section one-c of this article, for grade in rank, based on length of service, including that service</u>
- 5 served before and after the effective date of this section as a natural resources police officer as
- 6 follows: At the end of two years of service as a natural resources police officer, the officer shall
- 7 receive a salary increase of \$400 to be effective during his or her next year of service and a like
- 8 increase at yearly intervals thereafter, with the increases to be cumulative. A salary increase shall
- 9 be based upon years of service as of July 1 of each year and may not be recalculated until July 1 of
- 10 the following year.
- 11 Conservation Natural resources police officers in service at the time the amendment to this
- 12 section becomes effective shall be given credit for prior service and shall be paid salaries as the same
- 13 length of service will entitle them to receive under the provisions hereof.
- 14 (b) This section does not apply to special or emergency natural resources police officers
- 15 appointed under the authority of section one of this article.
- 16 §20-7-1c. Natural resources police officer, ranks, salary schedule, base pay, exceptions.
- 17 (a) Notwithstanding any provision of this code to the contrary, the ranks within the
- l8 law-enforcement section of the Division of Natural Resources are colonel, lieutenant colonel, major,
- 9 captain, lieutenant, sergeant, corporal, natural resources police officer first class, senior natural
- 20 resources police officer, natural resources police officer and natural resources police
- 21 officer-in-training. Each officer while in uniform shall wear the insignia of rank as provided by the

- 6 (d) Nothing in this section prohibits other pay increases as provided under section two, article
- 7 five, chapter five of this code: *Provided*, That any across-the-board pay increase granted by the
- 8 Legislature or the Governor will be added to, and reflected in, the minimum salaries set forth in this
- 9 section; and that any merit increases granted to an officer over and above the annual salary schedule
- 10 listed in subsection (b) of this section are retained by an officer when he or she advances from one
- 11 rank to another: *Provided, however*, That any natural resources police officer who receives an
- 12 increase in compensation pursuant to the amendment and reenactment of this section in 2011 shall
- 13 not receive any across-the-board pay increase granted by the Legislature or the Governor in 2011.

NOTE: The purpose of this bill is to provide an increase in compensation for Natural Resources Police officers.
