8	Whereas, The Governor submitted to the Legislature the Executive Budget document,				
9	dated January 13, 2016, which included a Statement of the State Fund, General Revenue, setting				
10	forth therein the cash balance as of July 1, 2015, and further included the estimate of revenue				
11	for the fiscal year 2016, less net appropriation balances forwarded and regular appropriations for				
12	the fiscal year 2016 and further included recommended expirations to the surplus balance of the				
13	State Fund, General Revenue; and				
14	Whereas, It appears from the Executive Budget document, Statement of the State Fund,				
15	General Revenue, and the passage of Senate Bill No. ### during the 2016 Regular Session of				
16	the Legislature, there now remains an unappropriated surplus balance in the State Treasury which				
17	is available for appropriation during the fiscal year ending June 30, 2016; therefore
