#### INTRODUCED H.B. 4316

A BILL to amend and reenact §18A-4-2a of the Code of West Virginia, 1931, as amended, relating
 to reimbursement of certification fee for National Board for Professional Teaching
 Standards certification; and requiring the submission of satisfactory evidence to the West
 Virginia Department of Education for reimbursement.

Be it enacted by the Legislature of West Virginia:

That §18A-4-2a of the Code of West Virginia, 1931, as amended, be amended and
reenacted to read as follows:

### **ARTICLE 4. SALARIES, WAGES AND OTHER BENEFITS.**

§18A-4-2a. State minimum salary bonus for classroom teachers with national board certification.

1 (a) The Legislature finds and declares that the rigorous standards and processes for 2 certification by the National Board for Professional Teaching Standards (NBPTS) helps to 3 promote the quality of teaching and learning. Therefore, classroom teachers in the public schools 4 of West Virginia should be encouraged to achieve national board certification through a 5 reimbursement of expenses and an additional salary bonus which reflects their additional 6 certification, to be paid in accordance with the provisions of this section.

7 (b) (1) Three thousand five hundred dollars shall be paid annually to each classroom 8 teacher who holds a valid certificate issued by the National Board of <u>for</u> Professional Teaching 9 Standards for the life of the certification, but in no event more than ten years for any one 10 certification.

(2) Three thousand five hundred dollars shall be paid annually to each classroom teacher
who holds a valid renewal certificate issued by the National Board of <u>for</u> Professional Teaching
Standards for the life of the renewal certificate, but in no event more than ten years for any one
renewal certificate.

15 (c) The payments:

16 (1) Shall be in addition to any amounts prescribed in the applicable state minimum salary17 schedule;

(2) Shall be paid in equal monthly installments; and

19 (3) Shall be considered a part of the state minimum salaries for teachers.

(d) For initial certification, one half of the certification fee shall be paid for reimbursement 20 21 once to each teacher who enrolls submits satisfactory evidence to the West Virginia Department 22 of Education of enrollment in the program for the National Board for Professional Teaching 23 Standards certification and as verified by the National Board for Professional Teaching Standards. 24 The remaining one half of the certification fee shall be paid for reimbursement once to each 25 teacher who completes submits satisfactory evidence to the West Virginia Department of 26 Education of completion of the National Board for Professional Teaching Standards certification 27 Completion shall be defined as the completion of ten scorable entries, as verified by the National 28 Board for Professional Teaching Standards. Teachers who achieve National Board for 29 Professional Teaching Standards certification may be reimbursed a maximum of \$600 for expenses actually incurred while obtaining the National Board for Professional Teaching 30 31 Standards certification.

(e) For renewal certification, each teacher who completes the National Board for
 Professional Teaching Standards certification renewal process shall be reimbursed for the
 renewal certification fee. Completion of the certification renewal process means <u>the submission</u>
 <u>of satisfactory evidence to the West Virginia Department of Education of</u> the successful renewal
 of the ten-year certification as verified by the National Board for Professional Teaching Standards.
 (f) The state board shall establish selection criteria for the teachers by the legislative rule

38 required pursuant to subsection (h) of this section.

(g) Funding for reimbursement of the initial certification fee and expenses actually incurred
while obtaining the National Board for Professional Teaching Standards certifications and funding
for reimbursement of the renewal certification fee shall be administered by the state Department
of Education from an appropriation established for that purpose by the Legislature. If funds
appropriated by the Legislature to accomplish the purposes of this subsection are insufficient, the

- 44 state department shall prorate the reimbursements for expenses and shall request of the
- 45 Legislature, at its next regular session, funds sufficient to accomplish the purposes of this
- 46 subsection, including needed retroactive payments.
- 47 (h) The state board shall promulgate legislative rules pursuant to article three-b, chapter
- 48 twenty-nine-a of this code to implement the provisions of this section.

NOTE: The purpose of this bill is to make a technical improvement in the language for reimbursement of teachers for fees upon enrollment, completion or renewal of National Board for Professional Teaching Standards (NBPTS) certification. Currently completion is defined as submitting "ten scorable entries," but the NBPTS has changed its definition several times over the years and the current statutory definition is no longer valid. The new language requires the submission of satisfactory evidence to the West Virginia Department of Education, rather than relying on a specific parameter of the NBPTS that may change.

Strike-throughs indicate language that would be stricken from a heading or the present law and underscoring indicates new language that would be added.
