1 AN ACT making a supplementary appropriation of federal funds out of the Treasury from the
2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,
3 2016, to the Department of Education, State Board of Education – School Lunch Program,
4 fund 8713, fiscal year 2016, organization 0402, and the Department of Education, State
5 Board of Education – Vocational Division, fund 8714, fiscal year 2016, organization 0402,
6 by supplementing and amending the appropriations for the fiscal year ending June 30,
7 2016.

8 Whereas, The Governor has established the availability of federal funds for expenditure
9 in the fiscal year ending June 30, 2016 which is hereby appropriated by the terms of this
10 supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2016, to fund 8713, fiscal
2 year 2016, organization 0402, be supplemented and amended by increasing an existing item of




