1 AN ACT making a supplementary appropriation of federal funds out of the Treasury from the
2 balance of federal moneys remaining unappropriated for the fiscal year ending June 30,
3 2016, to the Department of Commerce, WorkForce West Virginia – Workforce Investment
4 Act, fund 8749, fiscal year 2016, organization 0323, by supplementing and amending the
5 appropriations for the fiscal year ending June 30, 2016.

6 Whereas, The Governor has established the availability of federal funds for expenditure
7 in the fiscal year ending June 30, 2016 which is hereby appropriated by the terms of this
8 supplementary appropriation bill; *therefore*






