1 AN ACT making a supplementary appropriation of public moneys out of the Treasury from the
2 balance of moneys remaining unappropriated for the fiscal year ending June 30, 2016, to
3 the Department of Revenue, Tax Division – Wine Tax Administration Fund, fund 7087,
4 fiscal year 2016, organization 0702, and the Department of Revenue, Tax Division – Local
5 Sales Tax and Excise Tax Administration Fund, fund 7099, fiscal year 2016, organization
6 0702, by supplementing and amending the appropriations for the fiscal year ending June
7 30, 2016.

8 Whereas, The Governor has established that there now remains an unappropriated
9 balance in the Department of Revenue, Tax Division – Wine Tax Administration Fund, fund 7087,
10 fiscal year 2016, organization 0702, and in the Department of Revenue, Tax Division – Local
11 Sales Tax and Excise Tax Administration Fund, fund 7099, fiscal year 2016, organization 0702,
12 that is available for expenditure during the fiscal year ending June 30, 2016 which is hereby
13 appropriated by the terms of this supplementary appropriation bill; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2016, to fund 7087, fiscal
2 year 2016, organization 0702, be supplemented and amended by increasing an existing item of
