#### Enr SB 450

AN ACT making a supplementary appropriation of public moneys out of the Treasury from the
 balance of moneys remaining as an unappropriated surplus balance in the State Fund,
 General Revenue, to the Department of Health and Human Resources, Division of Health,
 fund 0407, fiscal year 2016, organization 0506, and the Department of Health and Human
 Resources, Division of Human Services, fund 0403, fiscal year 2016, organization 0511,
 by supplementing and amending the appropriations for the fiscal year ending June 30,
 2016.

8 Whereas, The Governor submitted to the Legislature the Executive Budget Document, 9 dated January 13, 2016, which included a Statement of the State Fund, General Revenue, setting 10 forth therein the cash balance as of July 1, 2015, and further included the estimate of revenues 11 for the fiscal year 2016, less net appropriation balances forwarded and regular appropriations for 12 the fiscal year 2016, and further included recommended expirations to the surplus balance of the 13 State Fund, General Revenue; and

Whereas, It appears from the Executive Budget Document, Statement of the State Fund, General Revenue, and the passage of Senate Bill 341 during the 2016 Regular Session of the Legislature, there now remains an unappropriated surplus balance in the State Treasury which is available for appropriation during the fiscal year ending June 30, 2016; therefore

Be it enacted by the Legislature of West Virginia:

That the total appropriation for the fiscal year ending June 30, 2016, to fund 0407, fiscal
year 2016, organization 0506, be supplemented and amended by increasing an existing item of
appropriation as follows:
