1 AN ACT to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section,
2 designated §9-5-25, relating to requiring Secretary of the Department of Health and
3 Human Resources contact surrounding states to establish a Medicaid compact; required
4 reporting; and setting forth purpose of the compact.

Be it enacted by the Legislature of West Virginia:

1 That the Code of West Virginia, 1931, be amended by adding thereto a new section,
2 designated §9-5-25, to read as follows:

ARTICLE 5. MISCELLANEOUS PROVISIONS.


§9-5-25. Medicaid program compact.

1 (a) The Secretary of the Department of Health and Human Resources shall contact West
2 Virginia's surrounding states to discuss the creation of a compact. This compact would enable
3 each states' health care providers to be eligible to be paid for services provided to the other states'
4 Medicaid participants.

5 (b) The Secretary shall provide a report on the creation of a Medicaid compact to the
6 Legislative Oversight Commission on Health and Human Resources Accountability before
7 October 31, 2017.




