1 AN ACT finding and declaring certain claims against the state and its agencies to be moral  
2 obligations of the state; and directing the Auditor to issue warrants for the payment thereof.

*Be it enacted by the Legislature of West Virginia:*

**§1. Finding and declaring certain claims against the Department of Administration;  
Division of Corrections; Department of Environmental Protection; Department of  
Health and Human Resources; Department of Health and Human Resources,  
Bureau for Behavioral Health and Health Facilities; Division of Highways; Division  
of Motor Vehicles; Regional Jail and Correctional Facility Authority; State Board of  
Education; State of West Virginia; and Department of Veterans Assistance to be  
moral obligations of the state and directing payment thereof.**

1 The Legislature has considered the findings of fact and recommendations reported to it  
2 by the Legislative Claims Commission concerning various claims against the state and agencies  
3 thereof and in respect to each of the following claims, the Legislature adopts those findings of fact  
4 as its own and in respect of the claims herein, the Legislature has independently made findings  
5 of fact and determinations of award and hereby declares it to be the moral obligation of the state  
6 to pay each such claim in the amount specified below and directs the Auditor to issue warrants  
7 for the payment thereof out of any fund appropriated and available for the purpose.
