A BILL making a supplementary appropriation of public moneys out of the Treasury from the
balance of moneys remaining as an unappropriated surplus balance in the State Fund,
General Revenue, to the Department of Health and Human Resources, Division of Health,
Central Office, fund 0407, fiscal year 2019, organization 0506, by supplementing and
amending the appropriations for the fiscal year ending June 30, 2019.

6 WHEREAS, The Governor submitted to the Legislature the Executive Budget document, 7 dated January 9, 2019, which included a Statement of the State Fund, General Revenue, setting 8 forth therein the cash balance as of July 1, 2018, and further included a revised estimate of 9 revenues for the fiscal year 2019, less net appropriation balances forwarded and regular 10 appropriations for the fiscal year 2019; and

WHEREAS, The Governor submitted to the Legislature an Executive Message dated
March 5, 2019, which included a revised estimate of revenues for the State Fund, General
Revenue and a statement of the State Fund, General Revenue for the fiscal year 2019; and

WHEREAS, The Governor submitted to the Legislature an Executive Message dated May
20, 2019, which included a revised estimate of revenues for the State Fund, General Revenue
and a statement of the State Fund, General Revenue for the fiscal year 2019; and

WHEREAS, The Governor submitted to the Legislature an Executive Message dated June
17, 2019, which included a revised estimate of revenues for the State Fund, General Revenue
and a statement of the State Fund, General Revenue for the fiscal year 2019; and

WHEREAS, It appears from the Statement of the State Fund, General Revenue, and
Executive messages, there remains an unappropriated surplus balance in the State Treasury
which is available for appropriation during the fiscal year ending June 30, 2019; therefore *Be it enacted by the Legislature of West Virginia:*

1 That the total appropriation for the fiscal year ending June 30, 2019, to fund 0407, fiscal 2 year 2019, organization 0506, be supplemented and amended by adding a new item of 3 appropriation as follows:
