### **House Bill 124**

BY DELEGATES HANSHAW (MR. SPEAKER) AND MILEY

BY REQUEST OF THE EXECUTIVE

[Introduced May 20, 2019]

1 A BILL expiring funds to the unappropriated surplus balance in the State Fund, General Revenue,  
 2 for the fiscal year ending June 30, 2019 in the amount of \$4,705,000 from the Treasurer’s  
 3 Office, Unclaimed Property Fund, fund 1324, fiscal year 2019, organization 1300, and  
 4 making a supplementary appropriation of public moneys out of the Treasury from the  
 5 balance of moneys remaining as an unappropriated surplus balance in the State Fund,  
 6 General Revenue, to the Executive, Governor’s Office, fund 0101, fiscal year 2019,  
 7 organization 0100, by supplementing and amending the appropriations for the fiscal year  
 8 ending June 30, 2019.

9 WHEREAS, The Governor finds that the account balance in the Treasurer’s Office,  
 10 Unclaimed Property Fund, fund 1324, fiscal year 2019, organization 1300 exceeds that which is  
 11 necessary for the purposes for which the account was established; therefore

12 *Be it enacted by the Legislature of West Virginia:*

13 That the balance of the funds available for expenditure in the fiscal year ending June 30,  
 14 2019, in the Treasurer’s Office, Unclaimed Property Fund, fund 1324, fiscal year 2019,  
 15 organization 1300 be decreased by expiring the amount of \$4,705,000 to the unappropriated  
 16 surplus balance of the State fund, General Revenue, to be available for appropriation during the  
 17 fiscal year ending June 30, 2019.

18 And, That the total appropriation for the fiscal year ending June 30, 2019, to fund 0101,  
 19 fiscal year 2019, organization 0100, be supplemented and amended by adding a new item of  
 20 appropriation as follows:
