AN ACT making a supplementary appropriation by adding a new item and increasing the
 expenditure of public moneys out of the Treasury from the balance of moneys remaining
 as an unappropriated balance in the State Fund - General Revenue, to the Department of
 Transportation - Division of Highways, fund 0620, fiscal year 2019, organization 0803, by
 supplementing and amending Chapter 12, Acts of the Legislature, Regular Session, 2018,
 known as the Budget Bill for the fiscal year ending June 30, 2019.

7 Whereas, The Governor submitted to the Legislature the Executive Budget Document, 8 dated January 9, 2019, which included a statement of the State Fund, General Revenue, setting 9 forth therein the cash balance as of July 1, 2018, and further included a revised estimate of 10 revenues for the fiscal year 2019, less net appropriation balances forwarded and regular 11 appropriations for the fiscal year 2019; and

Whereas, The Governor submitted to the Legislature an Executive Message, dated March
5, 2019, which included a revised estimate of revenues for the State Fund, General Revenue, for
the fiscal year 2019; and

Whereas, The Governor submitted to the Legislature an Executive Message, dated May
20, 2019, which included a revised estimate of revenues for the State Fund, General Revenue
and a statement of the State Fund, General Revenue for the fiscal year 2019; and

Whereas, It appears from the Executive Budget Document, statement of the State Fund, General Revenue, and Executive Messages, there remains an unappropriated balance in the State Treasury which is available for appropriation during the fiscal year ending June 30, 2019; therefore

Be it enacted by the Legislature of West Virginia:

That Chapter 12, Acts of the Legislature, Regular Session, 2018, known as the Budget
 Bill, be supplemented and amended by adding a new item of appropriation to Title II, Section 1
 thereof, the following:
