6	Whereas, The Governor submitted to the Legislature the Executive Budget Document,			
7	dated January 9, 2019, which included a statement of the State Fund, General Revenue, setting			
8	forth therein the cash balance as of July 1, 2019, and further included an estimate of revenues			
9	for the fiscal year 2020, less net appropriation balances forwarded and regular appropriations fo			
10	the fiscal year 2020; and			
11	Whereas, The Governor submitted to the Legislature an Executive Message, dated June			
12	17, 2019, which included a revised estimate of revenues for the fiscal year ending June 30, 2020			
13	and a statement of the State Fund, General Revenue, for the fiscal year 2020; and			
14	Whereas, It appears from the Executive Budget Document, statement of the State Fund,			
15	General Revenue, and the Executive Message, there remains an unappropriated balance in the			
16	State Treasury which is available for appropriation during the fiscal year ending June 30, 2020
