### **Senate Bill 404**

1 A BILL to amend and reenact §19-1B-4, §19-1B-6, §19-1B-7, §19-1B-10, and §19-1B-12a of the  
 2 Code of West Virginia, 1931, as amended, all relating generally to sediment control during  
 3 commercial timber harvesting operations; increasing the threshold amount before a logger  
 4 must follow certain licensing requirements regarding sediment control; requiring the logger  
 5 to notify the Director of the Division of Forestry at least three days before timbering begins;  
 6 requiring certain training requirements prior to recertification of certified loggers; providing  
 7 for appeals; increasing criminal penalties; and removing certain limitations on issuing  
 8 citations and powers of arrest.

*Be it enacted by the Legislature of West Virginia:*

**ARTICLE 1B. SEDIMENT CONTROL DURING COMMERCIAL TIMBER HARVESTING  
 OPERATIONS.**

**§19-1B-4. Timbering license required; requirement for license; exemption; annual fee;  
 rules.**

1 (a) A person may not conduct timbering operations, purchase timber or buy logs for resale  
 2 until he or she has obtained a license and met the requirements of this article.

3 (b) *Exemptions.*— A person who severs or removes, or hires or contracts with another to  
 4 sever or remove, standing trees from his or her own land is exempted from the timbering  
 5 operations licensure requirement of this section during any calendar year in which all trees  
 6 severed or removed by or for this owner have an aggregate stumpage value that does not exceed  
 7 ~~\$15,528~~ on behalf of the owner of record has a total gross sales value received by the exemption  
 8 holder of less than \$52,000. A person hired or contracted to sever or remove standing trees from  
 9 the land of another is exempted from the timbering operations licensure requirement of this  
 10 section during any calendar year in which all trees severed or removed by the hired or contracted  
 11 person have an aggregate stumpage value that does not exceed ~~\$15,528~~ has a total gross sales  
 12 value received by the exemption holder of less than \$52,000.

13 (c) An applicant for a timbering operation license shall submit an application and the fee  
14 of \$150 for each biennial renewal of the license. The application shall contain the following  
15 information:

16 (1) Name, address and telephone number of the applicant and if the applicant is a  
17 business entity other than a sole proprietor, the names and addresses of the principals, officers  
18 and resident agent of the business entity;

19 (2) The applicant's West Virginia business registration number or a copy of the current  
20 West Virginia business registration certificate. The Division of Forestry shall submit this  
21 information and a list of all applicants to the Tax Commissioner each month of the calendar year  
22 to ensure compliance with payment of severance, income withholding and all other applicable  
23 state taxes; and

24 (3) Any other information as required by the director.

25 (d) The director shall propose rules for legislative approval pursuant to the provisions of  
26 §29A-3-1 *et seq.* of this code, regarding the acquisition, suspension and revocation a license  
27 under this article. The rules are the proper subject of emergency legislative rules that may be  
28 promulgated in accordance with the provision of §15-3-15 of this code.

29 (e) The director shall prescribe a form providing the contents and manner of posting notice  
30 at the timbering operation. The notice shall include, at a minimum, the operator's name and  
31 license number.

**§19-1B-6. Notification of duration of timbering operations or harvesting of timber for sale;  
requirements thereof.**

1 (a) In addition to any other requirement of this article, no person may conduct timbering  
2 operations and no person may sever trees for sale unless the person notifies the director of the  
3 specific location on which the timbering operations or harvesting of timber are to be conducted.  
4 The notification shall be made in a manner designated by the director.

5 (1) All persons who conduct timbering operations or who harvest timber for sale, including

6 those persons who are specifically exempted from the licensure requirements of §19-1B-4 of this  
7 code, shall provide to the director of the division notification of harvesting of timber, which shall  
8 include:

9 (A) The name and address of the harvester of timber;

10 (B) The name and addresses of the owner or owners of the property upon which the timber  
11 is located;

12 (C) The business tax number or social security number of the harvester of timber; and

13 (D) An acknowledgment that the harvester of timber will conduct the harvest according to  
14 best management practices.

15 (2) In addition to the requirements of subdivision (1) of this subsection, persons who are  
16 subject to the licensure requirements of §19-1B-4 of this code shall provide to the director of the  
17 division notification of timbering operations, which shall include, at a minimum, the following:

18 (A) The specific topographic location where the timbering operations are to be conducted;

19 (B) The approximate dates that the timbering operation will begin and end;

20 (C) The approximate acreage over which timbering operations are contemplated;

21 (D) The names and addresses of the owner or owners of the timber to be harvested and,  
22 if different, the names and addresses of the owner or owners of the property upon which the  
23 timber is located;

24 (E) A sketch map of the proposed logging operation, including haul roads, landings and  
25 stream crossings;

26 (F) A description of the sediment control practices to be used by the logger during the  
27 timber harvesting operation;

28 (G) An acknowledgment that the operator will conduct the operations in compliance with  
29 the provisions of this article and any applicable rules promulgated pursuant to this article;

30 (H) A certification satisfactory to the director that all permits required under state law have  
31 been obtained or applied for and that all pertinent requirements for obtaining any permit applied

32 for, but not yet obtained, have been complied with; and

33 (l) The name or names of the person or persons who will be supervising the timbering  
34 operations at the site of the operations and his or her logger certification numbers.

35 (b) The notification shall be made ~~within~~ at least three days ~~of the beginning of the~~  
36 before the start of the operation.

37 (c) Further notice shall be given if the operation is to be, for any reason, closed more than  
38 seven days before the estimated date for closing provided under paragraph (B), subdivision (2),  
39 subsection (a) of this section.

**§19-1B-7. Certification of persons supervising timbering operations; timbering operations  
to be supervised; promulgation of rules.**

1 (a) Any individual supervising any licensed timbering operation, or any individual  
2 supervising any timbering operation that is not exempted from the licensing requirements set forth  
3 in §19-1B-4 of this code, must be certified pursuant to this section.

4 (b) The director is responsible for the development of standards and criteria for education,  
5 training and examination that must be successfully completed for persons to be certified to  
6 supervise any timbering operation. The certified logger shall ~~attend a training program every~~  
7 ~~four years after certification~~ complete four hours per year, for a cumulative total of eight  
8 hours of training every two years prior to recertification. The program for certified loggers  
9 shall provide for education and training in the safe conduct of timbering operations, in first aid  
10 procedures and in the use of best management practices to prevent soil erosion on timbering  
11 operations. The goals of this program will be to assure that timbering operations are conducted  
12 in accordance with applicable state and federal safety regulations in a manner that is  
13 environmentally sound and safe.

14 (c) The director shall provide programs using the resources of the division, other  
15 appropriate state agencies, educational entities and other qualified persons. Each inspector under

16 the jurisdiction of the chief shall attend a certification program free of charge and complete the  
17 certification requirements of this section.

18 (d) The director shall propose rules for legislative approval in accordance with §29A-3-1  
19 *et seq.* of this code, to effectuate the purposes of this article.

20 (e) Upon a person's successful completion of the certification requirements, the director  
21 shall provide proof of the completion by issuing a numbered certificate and a wallet-sized card to  
22 that person. The division shall maintain a record of each certificate issued and the person to whom  
23 it was issued.

24 (f) The certified logger shall submit a fee of \$150 for the initial certification application and  
25 the renewal application every two years thereafter.

26 (g) Every timbering operation that is required to be licensed under §19-1B-4 of this code  
27 must have at least one person certified pursuant to this section supervising the operation at any  
28 time the timbering operation is being conducted. All timbering operators shall be guided by the  
29 West Virginia forest practice standards and the West Virginia silvicultural best management  
30 practices to reduce sediment movement during a timber operation.

31 (h) The director shall, at no more than five-year intervals, convene a committee to review  
32 the best management practices to ensure that they reflect and incorporate the most current  
33 technologies. The committee shall, at a minimum, include a person researching silvicultural best  
34 management practices, a person in the field of silviculture, two loggers certified under this article,  
35 a representative of the Division of Water and Waste Management of the Department of  
36 Environmental Protection and a representative of an environmental organization. The director  
37 shall chair the committee and may amend the best management practices according to the  
38 suggestions of the committee for the next certification cycle.

**§19-1B-10. Orders of the director.**

1 Notwithstanding the provisions of §19-1B-5 of this code, whenever the director determines  
2 that any person has violated a provision of this article or any rules promulgated pursuant thereto,

3 he or she may enter an order directing the person to cease the violation and, where appropriate,  
4 to take such action to remediate damage created or to take action appropriate for the specific site.

5 ~~Any person having an interest which is or may be adversely affected by any order of the~~  
6 ~~director may file an appeal in accordance with the provisions of section eleven of this article~~ Any  
7 person or entity aggrieved by an order issued under the provisions of §19-1B-5(b) or §19-1B-5(c)  
8 of this code may file an appeal under the provisions of §19-1B-11 of this code.

9 Any persons or entity aggrieved by a suspension or revocation order issued under the  
10 provisions of §19-1B-5(e) or §19-1B-5(f) of this code may file an appeal in accordance with the  
11 provisions of §29A-5-1 et seq. and §29A-6-1 et seq. of this code.

#### **§19-1B-12a. Criminal and civil penalties.**

1 (a) It is illegal for a person to:

2 (1) Conduct timbering operations, purchase timber or buy logs for resale in this state  
3 without holding a valid license from the Director of the Division of Forestry, as required by §19-  
4 1B-4 of this code;

5 (2) Conduct timbering operations or sever trees for sale at a location in this state without  
6 providing the Director of the Division of Forestry with notice of the location where the timbering or  
7 harvesting operations are to be conducted, as required by §19-1B-6 of this code;

8 (3) Conduct a timbering operation in this state that is not supervised by a certified logger  
9 who holds a valid certificate from the Director of the Division of Forestry, as required by §19-1B-  
10 7 of this code.

11 (4) Continue to conduct timbering operations in violation of a suspension or revocation  
12 order that has been issued by the Director of the Division of Forestry or a conference panel under  
13 §19-1B-5, §19-1B-10 or §19-1B-11 of this code; and

14 (5) Fail to reclaim the real property in accordance with the best management practices set  
15 forth by the Division of Forestry and the committee established in §19-1B-7(h) of this code.

16 (b) *Criminal and civil penalties.* -- ~~A person that violates this section is guilty of a~~

17 ~~misdemeanor and, upon conviction, shall be fined not less than \$250 nor more than \$500 for each~~  
18 ~~violation.~~ A person that violates any provision of this section is guilty of a misdemeanor and, upon  
19 conviction, shall be fined not less than \$250 nor more than \$500 for the first offense, and for each  
20 subsequent offense, shall be fined not less than \$500 nor more than \$1,000, or confined in jail  
21 not more than six months, or both fined and confined. In addition to fines and costs, a person or  
22 entity convicted of a violation of this section shall pay a \$500 civil penalty to the division within 60  
23 days. The civil penalty shall be collected by the court in which the person is convicted and  
24 forwarded to the State Treasurer for deposit in the Division of Forestry Timber Operations  
25 Enforcement Fund (3082) for use in administering the provisions of this article.

26 (c) Each day that a person is in violation of this section constitutes a separate criminal and  
27 civil offense.

28 (d) In addition to any other law-enforcement agencies that have jurisdiction over criminal  
29 violations, any forester, ~~or~~ forest technician, or other person employed by the Division of  
30 Forestry who, as a part of his or her official duties is authorized by the Director of the Division of  
31 Forestry to inspect timbering operations, is authorized to issue citations for any of the listed  
32 violations in this article. ~~that he or she has witnessed. The limited authority granted to employees~~  
33 ~~of the Division of Forestry to issue citations to enforce the provisions of this section does not~~  
34 ~~include the power to place any individual or person under arrest~~

NOTE: The purpose of this bill is to alter certain sediment control requirements during commercial timber harvesting operations. The bill increases the threshold amount before a logger must follow certain licensing requirements regarding sediment control. The bill requires the logger to notify the Director of the Division of Forestry at least three days before timbering begins. The bill requires certain training requirements prior to recertification of certified loggers. The bill provides for appeals. The bill increases criminal penalties. The bill removes certain limitations on issuing citations and powers of arrest.

Strike-throughs indicate language that would be stricken from a heading or the present law and underscoring indicates new language that would be added.
