1 A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section, 2 designated §18-2-25c, relating to education; providing for the Tim Tebow Act; permitting 3 students instructed at home, by a private tutor or enrolled in a private, parochial, or church 4 school or a school operated by a religious order, who do not attend a school that is a 5 member of the West Virginia Secondary School Activities Commission to participate in 6 extracurricular activities that are under the authority of the commission at a school that is 7 a member of the commission; providing requirements, standards, and insurance 8 coverage; and providing that accommodating schools may not be impeded from 9 competing against other schools.

Be it enacted by the Legislature of West Virginia:

ARTICLE 2. STATE BOARD OF EDUCATION.

§18-2-25c. Tim Tebow Act; permitting students who are home-schooled or taught by a private tutor, or enrolled in a private, parochial or church school, or school operated by a religious order to participate in extracurricular activities at schools that are members of the West Virginia Secondary School Activity Commission.

1 (a) (1) This section shall be known and may be cited as the Tim Tebow Act.

2 (2) The purpose of this section is to allow students instructed at home or by a private tutor 3 or enrolled in a private, parochial or church school, or a school operated by a religious order, who 4 do not attend a school that is a member of the West Virginia Secondary School Activities 5 Commission (WVSSAC) and who are subject to §18-28-1 et seq. of this code, to participate in 6 extracurricular activities that are under the authority of the WVSSAC, including athletic teams, at 7 schools that are members of the WVSSAC. 8 (3) For purposes of this section, the term "member school" includes public schools and any nonpublic school that is a member of the West Virginia Secondary School Activities 9 10 Commission: Provided, That the nonpublic school has agreed to open its extracurricular activities 11 to Tebow students.

12	(4) For purposes of this section, a "Tebow student" includes students instructed at home
13	or by a private tutor or enrolled in a private, parochial or church school or a school operated by a
14	religious order, who do not attend a school that is a member of the West Virginia Secondary
15	School Activities Commission.
16	(5) For purposes of this section, the term "extracurricular activities" includes all programs
17	of the school that are under the authority of the WVSSAC.
18	(b) A Tebow student may participate in extracurricular activities sponsored by or engaged
19	in by a member school that the student would be authorized to attend pursuant to §18-5-16 of this
20	code in the case of a public school or otherwise authorized to attend in the case of a private,
21	parochial or church school, or a school operated by a religious order: Provided, That the
22	extracurricular activity is not offered at the private, parochial or church school or school operated
23	by a religious order where the Tebow student is enrolled. The student shall register with the county
24	board in the district where the student resides. Participation is conditioned on all of the following:
25	(1) The student registers with the school an intention to participate in the extracurricular
26	activities as a representative of the school;
27	(2) The student pays any participation or activity fee in an amount equal to the fee charged
28	to a member school participant;
29	(3) The student adheres to the same standards of behavior, responsibility, performance,
30	disciplinary procedures and penalties, and code of conduct as other participants of the team or
31	activity. If the student is convicted of, or is found to have committed, a felony or a delinquent act
32	which would have been a felony if committed by an adult, regardless of whether adjudication is
33	withheld, the participation of the student in interscholastic extracurricular activities is contingent
34	on established and published county board policy;
35	(4) The student adheres to the same academic standards as other participants of the team
36	or activity, with those standards confirmed by appropriate documentation provided to the member
37	school providing the activity in which the student is to participate. The student shall be able to

38	participate in curricular activities if that is a requirement of the extracurricular activity, including,
39	but not limited to, weight training. Appropriate documentation shall consist of the student's
40	transcript for the previous year and either of the following:
41	(A) The results of a nationally recognized standardized test, such as the ACT/Explore or
42	Plan College Readiness Test, Stanford Achievement Test, Comprehensive Test of Basic Skills,
43	Iowa Assessments, Terra Nova or California Achievement Test, which demonstrate that the
44	student is on grade level or, if grade equivalency is not available, that the student scores at a
45	minimum of the twenty-fifth percentile nationally without special accommodation; or
46	(B) A portfolio of the previous year's school work demonstrating the student's proficiency
47	appropriate for his or her grade level at the discretion of the school principal or guidance
48	counselor.
49	If the student was enrolled in a member school during the immediately preceding school
50	year, the student's eligibility shall be based on his or her academic performance at that school;
51	(5) The student complies with the same physical examination and immunization
52	requirements as other participants of the team or activity; and
53	(6) The student satisfies the same residency requirements as other students in the school
54	at which the student participates.
55	(c) A student of a member school who has been unable to maintain academic eligibility for
56	participation in extracurricular activities is ineligible to participate in the activities as a Tebow

64	duration of the school year. Notwithstanding the foregoing, a student may participate in different
65	extracurricular activities at the same member school and may seek eligibility under this section to
66	participate as a Tebow student the next school year.
67	(f) Student standards for participation in interscholastic extracurricular activities shall be
68	applied beginning with the first semester of the sixth-grade year of the student. A county board
69	may not establish requirements for participation in interscholastic extracurricular activities which
70	make participation in the activities less accessible to Tebow students than to other students.
71	Except as otherwise set forth in this section, evaluation processes or requirements that are placed
72	on Tebow student participants may not exceed those that apply to those students generally.
73	(g) Any insurance provided by a district school board for participants in extracurricular
74	activities shall cover a student permitted to participate by provisions of this section. If there is an
75	additional premium for the coverage, the Tebow student shall pay the additional premium.
76	(h)(1) No member school athletic team or group shall be impeded from competing against
77	any other member school team or group because the team or group includes students
78	participating pursuant to this section.
79	(2) A member school is prohibited from membership in any organization or entity which
80	regulates or governs interscholastic extracurricular activities and discriminates against students
81	eligible to participate pursuant to provisions of this section.
82	(i) This section does not guarantee that a student trying out for an interscholastic sport or
83	other extracurricular activity that is under the authority of the WVSSAC will make the team or
84	become part of another extracurricular activity, but only that the student shall not be prohibited
85	from trying out for the team or activity if the student is otherwise eligible, as outlined herein and
86	under the vulce of an expensionization or expension that regulates interachelectic enerty
	under the rules of an organization or association that regulates interscholastic sports.
