1 A BILL to amend and reenact §18A-4-8 and §18A-4-8a of the Code of West Virginia, 1931, as
 2 amended, all relating to creating three separate job titles for school bus operators; and
 3 establishing pay scales.

Be it enacted by the Legislature of West Virginia:

ARTICLE 4. SALARIES, WAGES AND OTHER BENEFITS.

§18A-4-8. Employment term and class titles of service personnel; definitions.

1 (a) The purpose of this section is to establish an employment term and class titles for
 2 service personnel. The employment term for service personnel may not be less than 10 months.
 3 A month is defined as 20 employment days. The county board may contract with all or part of
 4 these service personnel for a longer term.

5 (b) Service personnel employed on a yearly or 12-month basis may be employed by
 6 calendar months. Whenever there is a change in job assignment during the school year, the
 7 minimum pay scale and any county supplement are applicable.

8 (c) Service personnel employed in the same classification for more than the 200-day
 9 minimum employment term are paid for additional employment at a daily rate of not less than the
 10 daily rate paid for the 200-day minimum employment term.

11 (d) A service person may not be required to report for work more than five days per week
 12 without his or her agreement, and no part of any working day may be accumulated by the
 13 employer for future work assignments, unless the employee agrees thereto.

14 (e) If a service person whose regular work week is scheduled from Monday through Friday
 15 agrees to perform any work assignments on a Saturday or Sunday, the service person is paid for
 16 at least one-half day of work for each day he or she reports for work. If the service person works
 17 more than three and one-half hours on any Saturday or Sunday, he or she is paid for at least a
 18 full day of work for each day.

19 (f) A custodian, aide, maintenance, office and school lunch service person required to
 20 work a daily work schedule that is interrupted is paid additional compensation in accordance with

21 this subsection.

22 (1) A maintenance person means a person who holds a classification title other than in a
23 custodial, aide, school lunch, office or transportation category as provided in §18A-1-1 *et seq.* of
24 this code.

25 (2) A service person's schedule is considered to be interrupted if he or she does not work
26 a continuous period in one day. Aides are not regarded as working an interrupted schedule when
27 engaged exclusively in the duties of transporting students;

28 (3) The additional compensation provided in this subsection:

29 (A) Is equal to at least one eighth of a service person's total salary as provided by the state
30 minimum pay scale and any county pay supplement; and

31 (B) Is payable entirely from county board funds.

32 (g) When there is a change in classification or when a service person meets the
33 requirements of an advanced classification, his or her salary shall be made to comply with the
34 requirements of this article and any county salary schedule in excess of the minimum
35 requirements of this article, based upon the service person's advanced classification and
36 allowable years of employment.

37 (h) A service person's contract, as provided in §18A-2-5 of this code, shall state the
38 appropriate monthly salary the employee is to be paid, based on the class title as provided in this
39 article and on any county salary schedule in excess of the minimum requirements of this article.

40 (i) The column heads of the state minimum pay scale and class titles, set forth in §18A-4-
41 8a of this code, are defined as follows:

42 ~~(1)~~ "Pay grade" means the monthly salary applicable to class titles of service personnel;

43 ~~(2)~~ "Years of employment" means the number of years which an employee classified as a
44 service person has been employed by a county board in any position prior to or subsequent to
45 the effective date of this section and includes service in the Armed Forces of the United States, if
46 the employee was employed at the time of his or her induction. For the purpose of §18A-4-8a of

47 this code, years of employment is limited to the number of years shown and allowed under the
48 state minimum pay scale as set forth in §18A-4-8a of this code;

49 ~~(3)~~ "Class title" means the name of the position or job held by a service person;

50 ~~(4)~~ "Accountant I" means a person employed to maintain payroll records and reports and
51 perform one or more operations relating to a phase of the total payroll;

52 ~~(5)~~ "Accountant II" means a person employed to maintain accounting records and to be
53 responsible for the accounting process associated with billing, budgets, purchasing and related
54 operations;

55 ~~(6)~~ "Accountant III" means a person employed in the county board office to manage and
56 supervise accounts payable, payroll procedures, or both;

57 ~~(7)~~ "Accounts payable supervisor" means a person employed in the county board office
58 who has primary responsibility for the accounts payable function and who either has completed
59 twelve college hours of accounting courses from an accredited institution of higher education or
60 has at least eight years of experience performing progressively difficult accounting tasks.
61 Responsibilities of this class title may include supervision of other personnel;

62 ~~(8)~~ "Aide I" means a person selected and trained for a teacher-aide classification such as
63 monitor aide, clerical aide, classroom aide or general aide;

64 ~~(9)~~ "Aide II" means a service person referred to in the "Aide I" classification who has
65 completed a training program approved by the state board, or who holds a high school diploma
66 or has received a general educational development certificate. Only a person classified in an Aide
67 II class title may be employed as an aide in any special education program

68 ~~(10)~~ "Aide III" means a service person referred to in the "Aide I" classification who holds a
69 high school diploma or a general educational development certificate; and

70 (A) Has completed six semester hours of college credit at an institution of higher
71 education; or

72 (B) Is employed as an aide in a special education program and has one year's experience

73 as an aide in special education;

74 ~~(14)~~ “Aide IV” means a service person referred to in the “Aide I” classification who holds a
75 high school diploma or a general educational development certificate; and

76 (A) Has completed 18 hours of state board-approved college credit at a regionally
77 accredited institution of higher education, or

78 (B) Has completed 15 hours of state board-approved college credit at a regionally
79 accredited institution of higher education; and has successfully completed an in-service training
80 program determined by the state board to be the equivalent of three hours of college credit;

81 ~~(12)~~ “Audiovisual technician” means a person employed to perform minor maintenance on
82 audiovisual equipment, films, and supplies and who fills requests for equipment;

83 ~~(13)~~ “Auditor” means a person employed to examine and verify accounts of individual
84 schools and to assist schools and school personnel in maintaining complete and accurate records
85 of their accounts;

86 ~~(14)~~ “Autism mentor” means a person who works with autistic students and who meets
87 standards and experience to be determined by the state board. A person who has held or holds
88 an aide title and becomes employed as an autism mentor shall hold a multiclassification status
89 that includes both aide and autism mentor titles, in accordance with §18A-4-8b of this code.

90 ~~(15)~~ “Braille specialist” means a person employed to provide braille assistance to students.
91 A service person who has held or holds an aide title and becomes employed as a braille specialist
92 shall hold a multiclassification status that includes both aide and braille specialist title, in
93 accordance with §18A-4-8b of this code;

94 ~~(16)~~ “Bus operator” means a person employed to operate school buses and other school
95 transportation vehicles as provided by the state board

96 “Bus Operator I” means a person employed to operate school buses and other school
97 transportation vehicles as provided by the state board who has accumulated less than five years
98 service operating those vehicles;

99 “Bus Operator II” means a person employed to operate school buses and other school
100 transportation vehicles as provided by the state board who has accumulated at least five years
101 service operating those vehicles;

102 “Bus Operator III” means a person employed to operate school buses and other school
103 transportation vehicles as provided by the state board who has accumulated at least 10 years
104 service operating those vehicles;

105 ~~(17)~~ “Buyer” means a person employed to review and write specifications, negotiate
106 purchase bids and recommend purchase agreements for materials and services that meet
107 predetermined specifications at the lowest available costs;

108 ~~(18)~~ “Cabinetmaker” means a person employed to construct cabinets, tables, bookcases
109 and other furniture;

110 ~~(19)~~ “Cafeteria manager” means a person employed to direct the operation of a food
111 services program in a school, including assigning duties to employees, approving requisitions for
112 supplies and repairs, keeping inventories, inspecting areas to maintain high standards of
113 sanitation, preparing financial reports and keeping records pertinent to food services of a school;

114 ~~(20)~~ “Carpenter I” means a person classified as a carpenter's helper;

115 ~~(21)~~ “Carpenter II” means a person classified as a journeyman carpenter;

116 ~~(22)~~ “Chief mechanic” means a person employed to be responsible for directing activities
117 which ensure that student transportation or other county board-owned vehicles are properly and
118 safely maintained;

119 ~~(23)~~ “Clerk I” means a person employed to perform clerical tasks;

120 ~~(24)~~ “Clerk II” means a person employed to perform general clerical tasks, prepare reports
121 and tabulations, and operate office machines;

122 ~~(25)~~ “Computer operator” means a qualified person employed to operate computers;

123 ~~(26)~~ “Cook I” means a person employed as a cook's helper;

124 ~~(27)~~ “Cook II” means a person employed to interpret menus and to prepare and serve

125 meals in a food service program of a school. This definition includes a service person who has
126 been employed as a "Cook I" for a period of four years;

127 ~~(28)~~ "Cook III" means a person employed to prepare and serve meals, make reports,
128 prepare requisitions for supplies, order equipment and repairs for a food service program of a
129 school system;

130 ~~(29)~~ "Crew leader" means a person employed to organize the work for a crew of
131 maintenance employees to carry out assigned projects;

132 ~~(30)~~ "Custodian I" means a person employed to keep buildings clean and free of refuse;

133 ~~(31)~~ "Custodian II" means a person employed as a watchman or groundsman;

134 ~~(32)~~ "Custodian III" means a person employed to keep buildings clean and free of refuse,
135 to operate the heating or cooling systems and to make minor repairs;

136 ~~(33)~~ "Custodian IV" means a person employed as a head custodian. In addition to
137 providing services as defined in "Custodian III" duties may include supervising other custodian
138 personnel;

139 ~~(34)~~ "Director or coordinator of services" means an employee of a county board who is
140 assigned to direct a department or division.

141 (A) Nothing in this subdivision prohibits a professional person or a professional educator
142 from holding this class title;

143 (B) Professional personnel holding this class title may not be defined or classified as
144 service personnel unless the professional person held a service personnel title under this section
145 prior to holding the class title of "director or coordinator of services;"

146 (C) The director or coordinator of services is classified either as a professional person or
147 a service person for state aid formula funding purposes;

148 (D) Funding for the position of director or coordinator of services is based upon the
149 employment status of the director or coordinator either as a professional person or a service
150 person; and

151 (E) A person employed under the class title “director or coordinator of services” may not
152 be exclusively assigned to perform the duties ascribed to any other class title as defined in this
153 subsection: *Provided*, That nothing in this paragraph prohibits a person in this position from being
154 multiclassified;

155 ~~(35)~~ “Draftsman” means a person employed to plan, design and produce detailed
156 architectural/engineering drawings;

157 ~~(36)~~ “Early Childhood Classroom Assistant Teacher I” means a person who does not
158 possess minimum requirements for the permanent authorization requirements, but is enrolled in
159 and pursuing requirements;

160 ~~(37)~~ “Early Childhood Classroom Assistant Teacher II” means a person who has
161 completed the minimum requirements for a state-awarded certificate for early childhood
162 classroom assistant teachers as determined by the State Board;

163 ~~(38)~~ “Early Childhood Classroom Assistant Teacher III” means a person who has
164 completed permanent authorization requirements, as well as additional requirements comparable
165 to current paraprofessional certificate;

166 ~~(39)~~ “Educational Sign Language Interpreter I” means a person employed to provide
167 communication access across all educational environments to students who are deaf or hard of
168 hearing, and who holds the Initial Paraprofessional Certificate – Educational Interpreter pursuant
169 to state board policy;

170 ~~(40)~~ “Educational Sign Language Interpreter II” means a person employed to provide
171 communication access across all educational environments to students who are deaf or hard of
172 hearing, and who holds the Permanent Paraprofessional Certificate – Educational Interpreter
173 pursuant to state board policy;

174 ~~(41)~~ “Electrician I” means a person employed as an apprentice electrician helper or one
175 who holds an electrician helper license issued by the State Fire Marshal;

176 ~~(42)~~ “Electrician II” means a person employed as an electrician journeyman or one who

177 holds a journeyman electrician license issued by the State Fire Marshal;

178 ~~(43)~~ “Electronic technician I” means a person employed at the apprentice level to repair
179 and maintain electronic equipment;

180 ~~(44)~~ “Electronic technician II” means a person employed at the journeyman level to repair
181 and maintain electronic equipment;

182 ~~(45)~~ “Executive secretary” means a person employed as secretary to the county school
183 superintendent or as a secretary who is assigned to a position characterized by significant
184 administrative duties;

185 ~~(46)~~ “Food services supervisor” means a qualified person who is not a professional person
186 or professional educator as defined in §18A-1-1 of this code. The food services supervisor is
187 employed to manage and supervise a county school system's food service program. The duties
188 include preparing in-service training programs for cooks and food service employees, instructing
189 personnel in the areas of quantity cooking with economy and efficiency and keeping aggregate
190 records and reports;

191 ~~(47)~~ “Foreman” means a skilled person employed to supervise personnel who work in the
192 areas of repair and maintenance of school property and equipment;

193 ~~(48)~~ “General maintenance” means a person employed as a helper to skilled maintenance
194 employees, and to perform minor repairs to equipment and buildings of a county school system;

195 ~~(49)~~ “Glazier” means a person employed to replace glass or other materials in windows
196 and doors and to do minor carpentry tasks;

197 ~~(50)~~ “Graphic artist” means a person employed to prepare graphic illustrations;

198 ~~(51)~~ “Groundsman” means a person employed to perform duties that relate to the
199 appearance, repair and general care of school grounds in a county school system. Additional
200 assignments may include the operation of a small heating plant and routine cleaning duties in
201 buildings;

202 ~~(52)~~ “Handyman” means a person employed to perform routine manual tasks in any

203 operation of the county school system;

204 ~~(53)~~ "Heating and air conditioning mechanic I" means a person employed at the apprentice
205 level to install, repair and maintain heating and air conditioning plants and related electrical
206 equipment;

207 ~~(54)~~ "Heating and air conditioning mechanic II" means a person employed at the
208 journeyman level to install, repair and maintain heating and air conditioning plants and related
209 electrical equipment;

210 ~~(55)~~ "Heavy equipment operator" means a person employed to operate heavy equipment;

211 ~~(56)~~ "Inventory supervisor" means a person employed to supervise or maintain operations
212 in the receipt, storage, inventory and issuance of materials and supplies;

213 ~~(57)~~ "Key punch operator" means a qualified person employed to operate key punch
214 machines or verifying machines;

215 ~~(58)~~ "Licensed practical nurse" means a nurse, licensed by the West Virginia Board of
216 Examiners for Licensed Practical Nurses, employed to work in a public school under the
217 supervision of a school nurse;

218 ~~(59)~~ "Locksmith" means a person employed to repair and maintain locks and safes;

219 ~~(60)~~ "Lubrication man" means a person employed to lubricate and service gasoline or
220 diesel-powered equipment of a county school system;

221 ~~(61)~~ "Machinist" means a person employed to perform machinist tasks which include the
222 ability to operate a lathe, planer, shaper, threading machine and wheel press. A person holding
223 this class title also should have the ability to work from blueprints and drawings;

224 ~~(62)~~ "Mail clerk" means a person employed to receive, sort, dispatch, deliver or otherwise
225 handle letters, parcels and other mail;

226 ~~(63)~~ "Maintenance clerk" means a person employed to maintain and control a stocking
227 facility to keep adequate tools and supplies on hand for daily withdrawal for all school
228 maintenance crafts;

229 ~~(64)~~ “Mason” means a person employed to perform tasks connected with brick and block
230 laying and carpentry tasks related to these activities;

231 ~~(65)~~ “Mechanic” means a person employed to perform skilled duties independently in the
232 maintenance and repair of automobiles, school buses and other mechanical and mobile
233 equipment to use in a county school system;

234 ~~(66)~~ “Mechanic assistant” means a person employed as a mechanic apprentice and
235 helper;

236 ~~(67)~~ “Multiclassification” means a person employed to perform tasks that involve the
237 combination of two or more class titles in this section. In these instances the minimum salary
238 scale is the higher pay grade of the class titles involved;

239 ~~(68)~~ “Office equipment repairman I” means a person employed as an office equipment
240 repairman apprentice or helper;

241 ~~(69)~~ “Office equipment repairman II” means a person responsible for servicing and
242 repairing all office machines and equipment. A person holding this class title is responsible for the
243 purchase of parts necessary for the proper operation of a program of continuous maintenance
244 and repair;

245 ~~(70)~~ “Painter” means a person employed to perform duties painting, finishing and
246 decorating wood, metal and concrete surfaces of buildings, other structures, equipment,
247 machinery and furnishings of a county school system;

248 ~~(71)~~ “Paraprofessional” means a person certified pursuant to §18A-2a of this code to
249 perform duties in a support capacity including, but not limited to, facilitating in the instruction and
250 direct or indirect supervision of students under the direction of a principal, a teacher or another
251 designated professional educator.

252 (A) A person employed on the effective date of this section in the position of an aide may
253 not be subject to a reduction in force or transferred to create a vacancy for the employment of a
254 paraprofessional;

255 (B) A person who has held or holds an aide title and becomes employed as a
256 paraprofessional shall hold a multiclassification status that includes both aide and
257 paraprofessional titles in accordance with §18A-4-8b of this code; and

258 (C) When a service person who holds an aide title becomes certified as a paraprofessional
259 and is required to perform duties that may not be performed by an aide without paraprofessional
260 certification, he or she shall receive the paraprofessional title pay grade;

261 ~~(72)~~ "Payroll supervisor" means a person employed in the county board office who has
262 primary responsibility for the payroll function and who either has completed 12 college hours of
263 accounting from an accredited institution of higher education or has at least eight years of
264 experience performing progressively difficult accounting tasks. Responsibilities of this class title
265 may include supervision of other personnel;

266 ~~(73)~~ "Plumber I" means a person employed as an apprentice plumber and helper;

267 ~~(74)~~ "Plumber II" means a person employed as a journeyman plumber;

268 ~~(75)~~ "Printing operator" means a person employed to operate duplication equipment, and
269 to cut, collate, staple, bind and shelve materials as required;

270 ~~(76)~~ "Printing supervisor" means a person employed to supervise the operation of a print
271 shop;

272 ~~(77)~~ "Programmer" means a person employed to design and prepare programs for
273 computer operation;

274 ~~(78)~~ "Roofing/sheet metal mechanic" means a person employed to install, repair, fabricate
275 and maintain roofs, gutters, flashing and duct work for heating and ventilation;

276 ~~(79)~~ "Sanitation plant operator" means a person employed to operate and maintain a water
277 or sewage treatment plant to ensure the safety of the plant's effluent for human consumption or
278 environmental protection;

279 ~~(80)~~ "School bus supervisor" means a qualified person:

280 (A) Employed to assist in selecting school bus operators and routing and scheduling

281 school buses, operate a bus when needed, relay instructions to bus operators, plan emergency
282 routing of buses and promote good relationships with parents, students, bus operators and other
283 employees; and

284 (B) Certified to operate a bus or previously certified to operate a bus;

285 ~~(81)~~ "Secretary I" means a person employed to transcribe from notes or mechanical
286 equipment, receive callers, perform clerical tasks, prepare reports and operate office machines;

287 ~~(82)~~ "Secretary II" means a person employed in any elementary, secondary, kindergarten,
288 nursery, special education, vocational, or any other school as a secretary. The duties may include
289 performing general clerical tasks; transcribing from notes; stenotype, mechanical equipment or a
290 sound-producing machine; preparing reports; receiving callers and referring them to proper
291 persons; operating office machines; keeping records and handling routine correspondence.
292 Nothing in this subdivision prevents a service person from holding or being elevated to a higher
293 classification;

294 ~~(83)~~ "Secretary III" means a person assigned to the county board office administrators in
295 charge of various instructional, maintenance, transportation, food services, operations and health
296 departments, federal programs or departments with particular responsibilities in purchasing and
297 financial control or any person who has served for eight years in a position which meets the
298 definition of "Secretary II" or "Secretary III";

299 ~~(84)~~ "Sign Support Specialist" means a person employed to provide sign supported
300 speech assistance to students who are able to access environments through audition. A person
301 who has held or holds an aide title and becomes employed as a sign support specialist shall hold
302 a multiclassification status that includes both aide and sign support specialist titles, in accordance
303 with §18A-4-8b of this code.

304 ~~(85)~~ "Supervisor of maintenance" means a skilled person who is not a professional person
305 or professional educator as defined in §18A-1-1 of this code. The responsibilities include directing
306 the upkeep of buildings and shops, and issuing instructions to subordinates relating to cleaning,

307 repairs and maintenance of all structures and mechanical and electrical equipment of a county
308 board;

309 ~~(86)~~ "Supervisor of transportation" means a qualified person employed to direct school
310 transportation activities properly and safely, and to supervise the maintenance and repair of
311 vehicles, buses and other mechanical and mobile equipment used by the county school system.
312 After July 1, 2010, all persons employed for the first time in a position with this classification title
313 or in a multiclassification position that includes this title shall have five years of experience working
314 in the transportation department of a county board. Experience working in the transportation
315 department consists of serving as a bus operator, bus aide, assistant mechanic, mechanic, chief
316 mechanic or in a clerical position within the transportation department;

317 ~~(87)~~ "Switchboard operator-receptionist" means a person employed to refer incoming
318 calls, to assume contact with the public, to direct and to give instructions as necessary, to operate
319 switchboard equipment and to provide clerical assistance;

320 ~~(88)~~ "Truck driver" means a person employed to operate light or heavy duty gasoline and
321 diesel-powered vehicles;

322 ~~(89)~~ "Warehouse clerk" means a person employed to be responsible for receiving, storing,
323 packing and shipping goods;

324 ~~(90)~~ "Watchman" means a person employed to protect school property against damage
325 or theft. Additional assignments may include operation of a small heating plant and routine
326 cleaning duties;

327 ~~(91)~~ "Welder" means a person employed to provide acetylene or electric welding services
328 for a school system; and

329 ~~(92)~~ "WVEIS data entry and administrative clerk" means a person employed to work under
330 the direction of a school principal to assist the school counselor or counselors in the performance
331 of administrative duties, to perform data entry tasks on the West Virginia Education Information
332 System, and to perform other administrative duties assigned by the principal.

333 (j) Notwithstanding any provision in this code to the contrary, and in addition to the
334 compensation provided for service personnel in §18A-4-8a of this code, each service person is
335 entitled to all service personnel employee rights, privileges and benefits provided under this or
336 any other chapter of this code without regard to the employee's hours of employment or the
337 methods or sources of compensation.

338 (k) A service person whose years of employment exceeds the number of years shown and
339 provided for under the state minimum pay scale set forth in §18A-4-8a of this code may not be
340 paid less than the amount shown for the maximum years of employment shown and provided for
341 in the classification in which he or she is employed.

342 (l) Each county board shall review each service person's job classification annually and
343 shall reclassify all service persons as required by the job classifications. The state superintendent
344 may withhold state funds appropriated pursuant to this article for salaries for service personnel
345 who are improperly classified by the county boards. Further, the state superintendent shall order
346 a county board to correct immediately any improper classification matter and, with the assistance
347 of the Attorney General, shall take any legal action necessary against any county board to enforce
348 the order.

349 (m) Without his or her written consent, a service person may not be:

350 (1) Reclassified by class title; or

351 (2) Relegated to any condition of employment which would result in a reduction of his or
352 her salary, rate of pay, compensation or benefits earned during the current fiscal year; or for which
353 he or she would qualify by continuing in the same job position and classification held during that
354 fiscal year and subsequent years.

355 (n) Any county board failing to comply with the provisions of this article may be compelled
356 to do so by mandamus and is liable to any party prevailing against the board for court costs and
357 the prevailing party's reasonable attorney fee, as determined and established by the court.

358 (o) Notwithstanding any provision of this code to the contrary, a service person who holds

359 a continuing contract in a specific job classification and who is physically unable to perform the
360 job's duties as confirmed by a physician chosen by the employee, shall be given priority status
361 over any employee not holding a continuing contract in filling other service personnel job
362 vacancies if the service person is qualified as provided in §18A-4-8e of this code.

363 (p) Any person employed in an aide position on the effective date of this section may not
364 be transferred or subject to a reduction in force for the purpose of creating a vacancy for the
365 employment of a licensed practical nurse.

366 (q) Without the written consent of the service person, a county board may not establish
367 the beginning work station for a bus operator or transportation aide at any site other than a county
368 board-owned facility with available parking. The workday of the bus operator or transportation
369 aide commences at the bus at the designated beginning work station and ends when the
370 employee is able to leave the bus at the designated beginning work station, unless he or she
371 agrees otherwise in writing. The application or acceptance of a posted position may not be
372 construed as the written consent referred to in this subsection.

373 (r) Itinerant status means a service person who does not have a fixed work site and may
374 be involuntarily reassigned to another work site. A service person is considered to hold itinerant
375 status if he or she has bid upon a position posted as itinerant or has agreed to accept this status.
376 A county board may establish positions with itinerant status only within the aide and autism mentor
377 classification categories and only when the job duties involve exceptional students. A service
378 person with itinerant status may be assigned to a different work site upon written notice 10 days
379 prior to the reassignment without the consent of the employee and without posting the vacancy.
380 A service person with itinerant status may be involuntarily reassigned no more than twice during
381 the school year. At the conclusion of each school year, the county board shall post and fill,
382 pursuant to §18A-4-8b of this code, all positions that have been filled without posting by a service
383 person with itinerant status. A service person who is assigned to a beginning and ending work
384 site and travels at the expense of the county board to other work sites during the daily schedule,

385 is not considered to hold itinerant status.

386 (s) Any service person holding a classification title on June 30, 2013, that is removed from
387 the classification schedule pursuant to amendment and reenactment of this section in the year
388 2013, has his or her employment contract revised as follows:

389 (1) Any service person holding the Braille or Sign Language Specialist classification title
390 has that classification title renamed on his or her employment contract as either Braille Specialist
391 or Sign Support Specialist. This action does not result in a loss or reduction of salary or
392 supplement by any employee. Any seniority earned in the Braille or Sign Language Specialist
393 classification prior to July 1, 2013, continues to be credited as seniority earned in the Braille
394 Specialist or Sign Support Specialist classification;

395 (2) Any service person holding the Paraprofessional classification title and holding the
396 Initial Paraprofessional Certificate – Educational Interpreter has the title Educational Sign
397 Language Interpreter I added to his or her employment contract. This action does not result in a
398 loss or reduction of salary or supplement by any employee. Any seniority earned in the
399 Paraprofessional classification prior to July 1, 2013, continues to be credited as seniority earned
400 in the Educational Sign Language Interpreter I classification; and

401 (3) Any service person holding the Paraprofessional classification title and holding the
402 Permanent Paraprofessional Certificate – Educational Interpreter has the title Educational Sign
403 Language Interpreter II added to his or her employment contract. This action does not result in a
404 loss or reduction of salary or supplement by any employee. Any seniority earned in the
405 Paraprofessional classification prior to July 1, 2013, continues to be credited as seniority earned
406 in the Educational Sign Language Interpreter II classification;

407 (t) Any person employed as an aide in a kindergarten program who is eligible for full
408 retirement benefits before the first day of the instructional term in the 2020-2021 school year, may
409 not be subject to a reduction in force or transferred to create a vacancy for the employment of a
410 less senior Early Childhood Classroom Assistant Teacher;

411 (u) A person who has held or holds an aide title and becomes employed as an Early
 412 Childhood Classroom Assistant Teacher shall hold a multiclassification status that includes aide
 413 and/or paraprofessional titles in accordance with §18A-4-8b of this code.

§18A-4-8a. Service personnel minimum monthly salaries.

1 (a) The minimum monthly pay for each service employee shall be as follows:

2 (1) For school year ~~2018-2019~~ 2019-2020 and continuing thereafter, the minimum
 3 monthly pay for each service employee whose employment is for a period of more than three and

 104 person who holds a high school diploma or its equivalent.

105 (c) An additional \$11 per month also is added to the minimum monthly pay of each service
 106 person for each of the following:

107 (1) A service person who holds 12 college hours or comparable credit obtained in a trade
 108 or vocational school as approved by the state board;

109 (2) A service person who holds 24 college hours or comparable credit obtained in a trade
 110 or vocational school as approved by the state board;

111 (3) A service person who holds 36 college hours or comparable credit obtained in a trade
 112 or vocational school as approved by the state board;

113 (4) A service person who holds 48 college hours or comparable credit obtained in a trade
 114 or vocational school as approved by the state board;

115 (5) A service employee who holds 60 college hours or comparable credit obtained in a
116 trade or vocational school as approved by the state board;

117 (6) A service person who holds 72 college hours or comparable credit obtained in a trade
118 or vocational school as approved by the state board;

119 (7) A service person who holds 84 college hours or comparable credit obtained in a trade
120 or vocational school as approved by the state board;

121 (8) A service person who holds 96 college hours or comparable credit obtained in a trade
122 or vocational school as approved by the state board;

123 (9) A service person who holds 108 college hours or comparable credit obtained in a trade

150 (h) Any service person required to work on any legal school holiday is paid at a rate one
151 and one-half times the person's usual hourly rate.

152 (i) Any full-time service personnel required to work in excess of their normal working day
153 during any week which contains a school holiday for which they are paid is paid for the additional
154 hours or fraction of the additional hours at a rate of one and one-half times their usual hourly rate
155 and paid entirely from county board funds.

156 (j) A service person may not have his or her daily work schedule changed during the school
157 year without the employee's written consent and the person's required daily work hours may not
158 be changed to prevent the payment of time and one-half wages or the employment of another
159 employee.

160 (k) The minimum hourly rate of pay for extra duty assignments as defined in §18A-4-8b of
161 this code is no less than one seventh of the person's daily total salary for each hour the person is
162 involved in performing the assignment and paid entirely from local funds: *Provided*, That an
163 alternative minimum hourly rate of pay for performing extra duty assignments within a particular
164 category of employment may be used if the alternate hourly rate of pay is approved both by the
165 county board and by the affirmative vote of a two-thirds majority of the regular full-time persons

166 within that classification category of employment within that county: *Provided, however,* That the
167 vote is by secret ballot if requested by a service person within that classification category within
168 that county. The salary for any fraction of an hour the employee is involved in performing the
169 assignment is prorated accordingly. When performing extra duty assignments, persons who are
170 regularly employed on a one-half day salary basis shall receive the same hourly extra duty
171 assignment pay computed as though the person were employed on a full-day salary basis.

172 (l) The minimum pay for any service personnel engaged in the removal of asbestos
173 material or related duties required for asbestos removal is their regular total daily rate of pay and
174 no less than an additional \$3 per hour or no less than \$5 per hour for service personnel
175 supervising asbestos removal responsibilities for each hour these employees are involved in
176 asbestos-related duties. Related duties required for asbestos removal include, but are not limited
177 to, travel, preparation of the work site, removal of asbestos, decontamination of the work site,
178 placing and removal of equipment and removal of structures from the site. If any member of an
179 asbestos crew is engaged in asbestos-related duties outside of the employee's regular
180 employment county, the daily rate of pay is no less than the minimum amount as established in
181 the employee's regular employment county for asbestos removal and an additional \$30 per each
182 day the employee is engaged in asbestos removal and related duties. The additional pay for
183 asbestos removal and related duties shall be payable entirely from county funds. Before service
184 personnel may be used in the removal of asbestos material or related duties, they shall have
185 completed a federal Environmental Protection Act-approved training program and be licensed.
186 The employer shall provide all necessary protective equipment and maintain all records required
187 by the Environmental Protection Act.

188 (m) For the purpose of qualifying for additional pay as provided in §18A-5-8 of this code,
189 an aide is considered to be exercising the authority of a supervisory aide and control over pupils
190 if the aide is required to supervise, control, direct, monitor, escort, or render service to a child or
191 children when not under the direct supervision of a certified professional person within the

192 classroom, library, hallway, lunchroom, gymnasium, school building, school grounds, or wherever
193 supervision is required. For purposes of this section, “under the direct supervision of a certified
194 professional person” means that certified professional person is present, with and accompanying
195 the aide.
