1 AN ACT to amend and reenact §64-2-1 of the Code of West Virginia, 1931, as amended, relating  
2 to authorizing the Department of Administration to promulgate legislative rules; authorizing  
3 the rules as filed and as modified by the Legislative Rule-Making Review Committee;  
4 authorizing the Department of Administration to promulgate a legislative rule relating to  
5 purchasing; authorizing the Department of Administration to promulgate a legislative rule  
6 relating to state-owned vehicles; and authorizing the Department of Administration to  
7 promulgate a legislative rule relating to leasing of space and acquisition of real property  
8 on behalf of state spending units.

*Be it enacted by the Legislature of West Virginia:*

**ARTICLE 2. AUTHORIZATION FOR DEPARTMENT OF ADMINISTRATION TO  
PROMULGATE LEGISLATIVE RULES.**

**§64-2-1. Department of Administration.**

1 (a) The legislative rule filed in the State Register on July 18, 2018, authorized under the  
2 authority of §5A-3-4 of this code, relating to the Department of Administration (purchasing, 148  
3 CSR 1), is authorized.

4 (b) The legislative rule filed in the State Register on July 20, 2018, authorized under the  
5 authority of §5A-12-5 of this code, modified by the Department of Administration to meet the  
6 objections of the Legislative Rule-Making Review Committee and refiled in the State Register on  
7 November 14, 2018, relating to the Department of Administration (state-owned vehicles, 148 CSR  
8 3), is authorized.

9 (c) The legislative rule filed in the State Register on July 19, 2018, authorized under the  
10 authority of §5A-10-11 of this code, modified by the Department of Administration to meet the  
11 objections of the Legislative Rule-Making Review Committee and refiled in the State Register on  
12 November 14, 2018, relating to the Department of Administration (leasing of space and acquisition  
13 of real property on behalf of state spending units, 148 CSR 19), is authorized.
