1 AN ACT supplementing and amending by increasing existing items of appropriation and adding
2 a new item of appropriation of public moneys out of the Treasury in the State Fund,
3 General Revenue, to the Department of Health and Human Resources, Division of Health,
4 Central Office, fund 0407, fiscal year 2019, organization 0506; and to the Department of
5 Health and Human Resources, Division of Human Services, fund 0403, fiscal year 2019,
6 organization 0511, by supplementing and amending the appropriations for the fiscal year
7 ending June 30, 2019.

8 Whereas, The Governor submitted to the Legislature a statement of the State Fund,
9 General Revenue, dated January 9, 2019, setting forth therein the cash balance as of July 1,
10 2018; and further included the estimate of revenues for the fiscal year 2019, less net appropriation
11 balances forwarded and regular appropriations for fiscal year 2019; and

12 Whereas, The Governor submitted to the Legislature a statement of the State Fund,
13 General Revenue and Executive Message dated March 6, 2019, which included a revised
14 estimate of revenues for the fiscal year 2019; and

15 Whereas, It appears from the Governor’s statement of the State Fund, General Revenue,
16 and Executive Message, there now remains an unappropriated balance in the State Treasury
17 which is available for appropriation during the fiscal year ending June 30, 2019; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2019, to fund 0407, fiscal
2 year 2019, organization 0506, be supplemented and amended by increasing an existing item of
3 appropriation and adding a new item of appropriation as follows:
