A BILL expiring funds to the unappropriated surplus balance in the State Fund, General Revenue, for the fiscal year ending June 30, 2020 in the amount of \$30,658,000 from the balance of moneys remaining as an unappropriated balance in the State Excess Lottery Revenue Fund and making a supplementary appropriation of public moneys out of the Treasury from the unappropriated surplus balance in the State Fund, General Revenue, for the fiscal year ending June 30, 2020 to the Department of Administration – Public Defender Services, fund 0226, fiscal year 2020, organization 0221; to the Department of Health and Human Resources – Division of Human Services, fund 0403, fiscal year 2020, organization 0511, and to the Department of Veterans' Assistance – Department of Veterans' Assistance, fund 0456, fiscal year 2020, organization 0613.

Whereas, The Governor submitted the Executive Budget Document to the Legislature on January 8, 2020, containing a statement of the State Fund, General Revenue, setting forth therein the cash balance as of July 1, 2019, and further included the estimate of revenue for the fiscal year 2020, less net appropriation balances forwarded and regular and surplus appropriations for the fiscal year 2020, and further included recommended expirations to the unappropriated surplus balance of the State Fund General Revenue; and

Whereas, It appears from the Governor's Statement of the State Excess Lottery Revenue Fund, there now remains an unappropriated balance in the State Treasury which is available for expiration during the fiscal year ending June 30, 2020; and

Whereas, It appears from the Governor's Statement of the State Fund, General Revenue, and this legislation, there now remains an unappropriated surplus balance in the Treasury which is available for appropriation during the fiscal year ending June 30, 2020; therefore

Be it enacted by the Legislature of West Virginia:

That the balance of the funds remaining as an unappropriated balance for the fiscal year ending June 30, 2020 in the State Excess Lottery Revenue Fund be decreased by expiring the amount of \$30,658,000 to the unappropriated surplus balance of the State Fund, General
