4	8319, fiscal year 2020, organization 0803, and to the Department of Transportation, State
5	Rail Authority, West Virginia Commuter Rail Access Fund, fund 8402, fiscal year 2020,
6	organization 0804, by supplementing and amending the appropriations for the fiscal year
7	ending June 30, 2020.
8	Whereas, The Governor has established that there now remains an unappropriated
9	balance in the Department of Transportation, Division of Highways, A. James Manchin Fund, fund
10	8319, fiscal year 2020, organization 0803, and in the Department of Transportation, State Rail
11	Authority, West Virginia Commuter Rail Access Fund, fund 8402, fiscal year 2020, organization
12	0804, that is available for expenditure during the fiscal year ending June 30, 2020, which is hereby
13	appropriated by the terms of this supplementary appropriation bill; therefore
