1 AN ACT to amend and reenact §8-14-12 of the Code of West Virginia, 1931, as amended, relating
2 to removing the residency requirement for persons applying for reappointment to a
3 municipal police department.

Be it enacted by the Legislature of West Virginia:

**ARTICLE 14. LAW AND ORDER; POLICE FORCE OR DEPARTMENTS; POWERS,
AUTHORITY, AND DUTIES OF LAW-ENFORCEMENT OFFICIALS AND
POLICEMEN; POLICE MATRONS; SPECIAL SCHOOL ZONE AND PARKING
LOT OR PARKING BUILDING POLICE OFFICERS; CIVIL SERVICE FOR
CERTAIN POLICE DEPARTMENTS.**

§8-14-12. Form of application; age and residency requirements; exceptions.

1 (a) The policemen's civil service commission in each Class I and Class II city shall require
2 a person applying for admission to any competitive examination provided under the civil service
3 provisions of this article or under the commission's rules to file in its office, within a reasonable
4 time prior to the proposed examination, a formal application in which the applicant shall state
5 under oath or affirmation:

6 (1) The applicant's full name, residence, and post-office address;

7 (2) The applicant's United States citizenship, age, and the place and date of the applicant's
8 birth;

9 (3) The applicant's state of health and the applicant's physical capacity for the public
10 service;

11 (4) The applicant's business and employments and residences for at least three previous
12 years; and

13 (5) Other information as may reasonably be required, touching upon the applicant's
14 qualifications and fitness for the public service.

15 (b) Applications shall be furnished by the commission, without charge. The commission
16 may require, in connection with the application, the certificates of citizens, physicians, and others,
17 having pertinent knowledge concerning the applicant, as the good of the service may require.

18 (c) Notwithstanding the provisions of §11-5-1 *et seq.* of this code, a person may not submit
19 an application for original appointment if the person is less than 18 years of age or more than 40
20 years of age at the date of the individual's application.

21 (d) Notwithstanding the requirements established in this section, if an applicant: (1)
22 Formerly served upon the paid police department of the city to which he or she makes application,
23 for a period of more than his or her probationary period; (2) resigned from the department at a
24 time when there were no charges of misconduct or other misfeasance pending against the
25 applicant; and (3) applies for appointment by reinstatement within a period of two years from the
26 date of resignation from the paid police department to which the individual seeks appointment by
27 reinstatement, then the individual is eligible for appointment by reinstatement in the discretion of
28 the policemen's civil service commission. The applicant may be over the age of 40 years. The
29 applicant, providing his or her former term of service so justifies, may be appointed by
30 reinstatement to the paid police department without a competitive examination, but the applicant
31 shall undergo a medical examination. The applicant shall be the lowest in rank in the department
32 next above the probationers of the department.
