1 AN ACT making a supplementary appropriation of Lottery Net Profits from the balance of moneys
2 remaining as an unappropriated balance in Lottery Net Profits to the Bureau of Senior
3 Services, Lottery Senior Citizens Fund, fund 5405, fiscal year 2020, organization 0508, by
4 supplementing and amending the appropriations for the fiscal year ending June 30, 2020.

5 Whereas, The Governor submitted the Executive Budget Document to the Legislature on
6 January 8, 2020, which included a statement of the Lottery Fund setting forth therein the
7 unappropriated cash balance as of July 1, 2019, and further included the estimate of revenues
8 for the fiscal year 2020, less regular appropriations for fiscal year 2020; and

9 Whereas, It appears from the Governor's statement of the Lottery Fund there now remains
10 an unappropriated balance in the State Treasury which is available for appropriation during the
11 fiscal year ending June 30, 2020; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2020, to fund 5405, fiscal
2 year 2020, organization 0508, be supplemented and amended by increasing an existing item of
3 appropriation as follows:

5 **Sec. 4. Appropriations from lottery net profits.**

13 Any unexpended balance remaining in the appropriation for In-Home Services and
14 Nutrition for Senior Citizens (fund 5405, appropriation 91700) is hereby reappropriated for
15 expenditure during the fiscal year 2021.

16 From the above appropriation for In-Home Services and Nutrition for Senior Citizens (fund
17 5405, appropriation 91700) \$1,500,000 shall be utilized for congregate and home-delivered
18 nutrition meal reimbursement rate increases and \$1,500,000 shall be utilized for the nutrition
19 home-delivered meal program wait list.
