4	the Department of Administration, Division of Personnel, fund 0206, fiscal year 2021,				
5	organization 0222, by supplementing and amending Chapter 11, Acts of the Legislature,				
6	Regular Session, 2020, known as the Budget Bill for the fiscal year ending June 30, 2021.				
7	Whereas, The Governor submitted to the Legislature the Executive Budget Document,				
8	dated February 10, 2021, which included a Statement of the State Fund, General Revenue,				
9	setting forth therein the cash balance as of July 1, 2020, and further included an estimate of				
10	revenues for the fiscal year 2021, less net appropriation balances forwarded and regular				
11	appropriations for the fiscal year 2021; and				
12	Whereas, The Governor submitted to the Legislature an Executive Message dated June				
13	7, 2021, which included a revised estimate of revenues for the State Fund, General Revenue,				
14	and a Statement of the State Fund, General Revenue, for the fiscal year 2021; and				
15	Whereas, The Governor submitted to the Legislature an Executive Message dated June				
16	24, 2021, which included a revised estimate of revenues for the State Fund, General Revenue,				
17	and a Statement of the State Fund, General Revenue, for the fiscal year 2021; and				
18	Whereas, It appears from the Statement of the State Fund, General Revenue, and				
19	Executive messages, there remains an unappropriated balance in the State Treasury which is				
20	available for appropriation during the fiscal year ending June 30, 2021; therefore				
	Be it enacted by the Legislature of West Virginia:				
1	That Chapter 11, Acts of the Legislature, Regular Session, 2020, known as the Budget				
2	Bill, be supplemented and amended by adding a new item of appropriation to Title II, Section 1				

3 thereof, the following:
