Senate Bill 3017

BY SENATORS BLAIR (MR. PRESIDENT) AND BALDWIN

(BY REQUEST OF THE EXECUTIVE)

[Passed October 14, 2021; in effect from passage]

1 AN ACT supplementing and amending the appropriations of public moneys out of the Treasury
2 from the balance of moneys remaining as an unappropriated balance in the State Fund,
3 General Revenue, to the Department of Economic Development, Department of Economic
4 Development – Office of the Secretary, fund 0256, fiscal year 2022, organization 0307, by
5 supplementing and amending the appropriations for the fiscal year ending June 30, 2022.

1 Whereas, The Governor submitted to the Legislature the Executive Budget Document,
2 dated February 10, 2021, which included a Statement of the State Fund, General Revenue,
3 setting forth therein the cash balance as of July 1, 2020, and further included an estimate of
4 revenues for the fiscal year 2022 less net appropriation balances forwarded and regular
5 appropriations for the fiscal year 2022; and

6 Whereas, The Governor submitted to the Legislature an Executive Message dated June
7 24, 2021, which included a revised estimate of revenues for the State Fund, General Revenue,
8 and a Statement of the State Fund, General Revenue, for the fiscal year 2021, and further
9 included an estimate of revenues for the fiscal year 2022 less net appropriation balances
10 forwarded and regular appropriations for the fiscal year 2022; and

11 Whereas, It appears from the Executive Message dated June 24, 2021, Statement of the
12 State Fund, General Revenue, there remains an unappropriated balance in the State Treasury
13 which is available for appropriation during the fiscal year ending June 30, 2022; therefore

Be it enacted by the Legislature of West Virginia:

1 That the total appropriation for the fiscal year ending June 30, 2022, to fund 0256, fiscal
2 year 2022, organization 0307, be supplemented and amended by adding a new item of
3 appropriation as follows:
