1	A BILL supplementing and amending appropriations of public moneys out of the Treasury in the
2	State Fund, General Revenue, by decreasing existing items of appropriation from the
3	Department of Health and Human Resources, Division of Human Services, fund 0403,
4	fiscal year 2021, organization 0511 and from the Department of Health and Human
5	Resources, Division of Health – Central Office, fund 0407, fiscal year 2021, organization
6	0506 and increasing an existing item of appropriation to the Department of Health and
7	Human Resources, Division of Human Services, fund 0403, fiscal year 2021, organization
8	0511, by supplementing and amending appropriations for the fiscal year ending June 30,
9	2021.
10	WHEREAS, The Governor submitted to the Legislature the Executive Budget document,
11	dated February 10, 2021, which included a Statement of the State Fund, General Revenue,
12	setting forth therein the cash balance as of July 1, 2020, and further included the estimate of
13	revenues for the fiscal year 2021, less net appropriation balances forwarded and regular
14	appropriations for the fiscal year 2021; and
15	WHEREAS, It appears from the Executive Budget document, Statement of the State Fund,
16	General Revenue, and this legislation, there remains an unappropriated balance in the State
17	Treasury which is available for appropriation during the fiscal year ending June 30, 2021;
18	therefore
19	Be it enacted by the Legislature of West Virginia:
20	That the total appropriation for the fiscal year ending June 30, 2021, to fund 0403, fiscal
21	year 2021, organization 0511, be supplemented and amended by decreasing an existing item of
22	appropriation as follows:
