1	A BILL supplementing and amending appropriations of public moneys out of the Treasury in the		
2	State Fund, General Revenue, by decreasing an existing item of appropriation and adding		
3	a new item of appropriation to Executive, Governor's Office, fund 0101, fiscal year 2021,		
4	organization 0100, by supplementing and amending appropriations for the fiscal year		
5	ending June 30, 2021.		
6	WHEREAS, The Governor submitted to the Legislature the Executive Budget document,		
7	dated February 10, 2021, which included a Statement of the State Fund, General Revenue		
8	setting forth therein the cash balance as of July 1, 2020, and further included the estimate of		
9	revenues for the fiscal year 2021, less net appropriation balances forwarded and regular		
10	appropriations for the fiscal year 2021; and		
11	WHEREAS, It appears from the Executive Budget document, Statement of the State Fund,		
12	General Revenue, and this legislation, there remains an unappropriated balance in the State		
13	Treasury which is available for appropriation during the fiscal year ending June 30, 2021;		
14	therefore		
15	Be it enacted by the Legislature of West Virginia:		
16	That the total appropriation for the fiscal year ending June 30, 2021, to fund 0101, fiscal		
17	year 2021, organization 0100, be supplemented and amended by decreasing an existing item of
