1 AN ACT making a supplementary appropriation of public monies out of the Treasury from the  
2 balance of monies remaining unappropriated for the fiscal year ending June 30, 2021, to  
3 the Department of Homeland Security, Department of Homeland Security – Office of the  
4 Secretary – Law-Enforcement, Safety and Emergency Worker Funeral Expense Payment  
5 Fund, fund 6003, fiscal year 2021, organization 0601, by supplementing and amending  
6 the appropriations for the fiscal year ending June 30, 2021.

1 WHEREAS, The Governor has established that there now remains an unappropriated  
2 balance in the Department of Homeland Security, Department of Homeland Security – Office of  
3 the Secretary – Law-Enforcement, Safety and Emergency Worker Funeral Expense Payment  
4 Fund, fund 6003, fiscal year 2021, organization 0601, that is available for expenditure during the  
5 fiscal year ending June 30, 2021 which is hereby appropriated by the terms of this supplementary  
6 appropriation bill; therefore

7 *Be it enacted by the Legislature of West Virginia:*

8 That the total appropriation for the fiscal year ending June 30, 2021, to fund 6003, fiscal  
9 year 2021, organization 0601, be supplemented and amended by increasing an existing item of  
10 appropriation as follows:






