5	year ending June 30, 2022.			
6	WHEREAS, The Governor submitted the Executive Budget Document to the Legislature			
7	on January 12, 2022, containing a statement of the State Fund, General Revenue, setting fort			
8	therein the cash balance as of July 1, 2021, and further included the revised estimate of revenue			
9	for the fiscal year 2022, less net appropriation balances forwarded and regular and surplus			
10	appropriations for the fiscal year 2022; and			
11	WHEREAS, It appears from the Executive Budget document, Statement of the State Fund,			
12	General Revenue, and this legislation, there remains an unappropriated balance in the State			
13	Treasury which is available for appropriation during the fiscal year ending June 30, 2022
