1 A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new article, 2 designated §11-13MM-1, §11-13MM-2, §11-13MM-3, §11-13MM-4, §11-13MM-5, §11-3 13MM-6, and §11-13MM-7, all relating to the creation of the West Virginia Business 4 Incentive Program; providing for a short title; providing for legislative findings and purpose: 5 creating the program and setting forth qualifications; setting forth a penalty for failure to 6 keep records; providing for rulemaking; providing for the application of the West Virginia 7 Tax Procedure and Administration Act and West Virginia Tax Crimes and Penalties Act to 8 the West Virginia Business Incentive Program; and providing for an effective date.

Be it enacted by the Legislature of West Virginia:

ARTICLE 13MM. BUSINESS INCENTIVE PROGRAM.

§11-13MM-1. Short title.

This article may be cited as the "West Virginia Business Incentive Program."

- §11-13MM-2. Legislative findings and purpose. 1 The Legislature finds that the creation of new labor through existing businesses in this 2 state, and the expansion, growth and revitalization of labor is in the public interest and promotes 3 the general welfare of the people of this state. By adding a tax rebate incentive to existing 4 businesses, those businesses will have more reason to stay and expand in our state. §11-13MM-3. Business tax rebate program defined; qualifications. 1 (a) There is hereby established the West Virginia Business Incentive Program. 2 (b) Businesses located in West Virginia shall be eligible for a 10% rebate on the payment of 3 the amount of the annual growth of their business equipment and business inventory taxes for 4 each additional job that is created during year. The rebate percentage shall only be applied to the 5 increase of the tax from the previous year to the current year. 6 (c) Money for the rebate shall be transferred from the state's General Revenue fund 7 through the Department of Economic Development. 8
 - (d) West Virginia businesses seeking the rebate shall apply through the Department of

9 <u>Economic Development, and approval shall be based on the following criteria:</u>

10 (1) The business shall be located in West Virginia and currently pay business equipment

11 and/or business inventory taxes in this state;

- 12 (2) The business must be in good standing with both county and state tax departments;
- 13 (3) The amount of annual W-2 forms shall determine the number of employees for both the
- 14 previous and current year;
- 15 (4) The annual payroll must increase by 10% within the state of West Virginia; and
- 16 (5) At least 80% of the company's employees must reside in the state of West Virginia.
- 17 (e) Employees being claimed under the West Virginia Business Incentive Program as
- 18 <u>newly created jobs shall be West Virginia residents.</u>

§11-13MM-4. Failure to keep records for West Virginia Business Incentive Program.

- 1 Any business who does not keep the records required for purposes of the West Virginia
- 2 Business Incentive Program under section 3 of this article shall not be eligible for the incentive
- 3 program until all records are provided.

§11-13MM-5. Rulemaking.

- 1 (a) In order to effectuate the purposes of this article, the Tax Commissioner may 2 promulgate procedural rules, interpretive rules and legislative rules, including emergency rules, or
- 3 any combination thereof, in accordance with §29A-3-1 *et seq.* of this code.
- 4 (b) In order to effectuate the purposes of this article, the Department of Economic
- 5 Development or any agency, division or subdivision thereof, may promulgate procedural rules,
- 6 interpretive rules and legislative rules, including emergency rules, or any combination thereof, in
- 7 accordance with §29A-3-1 et seq. of this code.

§11-13MM-6. Application of the West Virginia Tax Procedure and Administration Act andWestVirginiaTaxCrimesandPenaltiesAct.1The provisions of this article are subject to the West Virginia Tax Procedure and2Administration Act, set forth in §11-10-1 *et seg.* of this code, and the West Virginia Tax Crimes and

- 3 Penalties Act, set forth in §11-9-1 et seq. of this code, as if the provisions thereof were set forth in
- 4 <u>extenso in this article.</u>

<u>§11-13MM-7.</u>	Effective	date.

- 1 This article shall be effective for corporate net income tax years and personal income tax
- 2 years beginning on and after January 1, 2023, with retrospective effective back to such date.
