FISCAL NOTE A BILL to amend and reenact §18A-2-13 of the Code of West Virginia, 1931, as amended, relating
to changing the recommended guidelines for full-day and half-day cooks to the minimum
ratio of one cook for every 110 meals prepared and served.

Be it enacted by the Legislature of West Virginia:

ARTICLE 2. SCHOOL PERSONNEL.

§18A-2-13. Recommended guidelines for full-day and half-day cooks.
