A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section,
 designated §7-1-4a, relating to the creation of the "County Home Rule Program."
 Be it enacted by the Legislature of West Virginia:

ARTICLE 1. COUNTY COMMISSIONS GENERALLY. Home §7-1-4a. County Rule Program. 1 (a) The Legislature finds and declares that: 2 (1) Counties face challenges delivering services required by federal and state law or 3 demanded by their constituents; 4 (2) Counties are sometimes restrained by state statutes, policies, and rules that challenge 5 their ability to carry out their duties and responsibilities in a cost-effective, efficient, and timely 6 manner; 7 (3) Establishing a County Home Rule Program as a permanent program is in the public 8 interest. 9 (b) The County Home Rule Program is established as a permanent program and shall be 10 identified as the County Home Rule Program. 11 (c)(1) Commencing July 1, 2024, any County that is current in payment of all state fees 12 may apply to participate in the County Home Rule Program pursuant to the provisions of this 13 section. 14 (2) A County wishing to participate in the County Home Rule Program must secure the 15 support of a simple majority of ballots cast by its constituents through a ballot referendum during a 16 normal primary or general election. Provided, That if the County Home Rule Program is passed in 17 a county, the Program shall sunset after a period of six years. 18 (d) The Counties participating in the County Home Rule Program may not pass an ordinance, act, resolution, rule, or regulation, under the provisions of this section, that is contrary 19 20 to the following:

- 31 state crimes and punishment;
- 32 (11) Laws governing pensions or retirement plans;
- 33 (12) Laws governing annexation;
- 34 (13) Laws governing taxation:
- 35 (A) *Provided*, That a participating County may enact a County sales tax up to one percent if
- 36 <u>it eliminates its County Stormwater Management Fee if applicable:</u>
- 37 (B) Provided, however, That if a County subsequently reinstates the Stormwater

38 Management Fee it previously eliminated, or enacts a Stormwater Management Fee it did not

39 <u>have previously; it shall eliminate the County sales tax enacted under the County Home Rule</u>

- 41 (C) *Provided further*, That any County imposing a sales tax, may not impose the tax inside
 42 any municipality within that county that already has a municipal sales tax under 8-1-5a.
- 43 (D) And provided further, That any County that imposes a County sales tax pursuant to this
- 44 section shall use the services of the Tax Commissioner to administer, enforce, and collect the tax
- 45 required by the provisions of §11-15-1 et seq., §11-15A-1 et seq., and §11-15B-1 et seq. of this
- 46 code and all applicable provisions of the Streamlined Sales and Use Tax Agreement. The tax
- 47 described in subsection (h) does not apply to the sale of motor fuel or motor vehicles;

74	(2) Enacts an occupation tax, fee, or assessment payable by a nonresident of a County; or
75	(3) Imposes duties on another governmental entity, unless the performance of the duties is
76	part of a legally executed agreement between the County and the other governmental entity, or is
77	otherwise permitted by state law;
78	(f) Counties may not prohibit or effectively limit the rental of a property, in whole or in part,
79	or regulate the duration, frequency, or location of such rental, in whole or in part. A County may
80	regulate activities that arise when a property is used as a rental: Provided, That such regulation
81	applies uniformly to all properties, without regard to whether such properties are used as a rental:
82	Provided, however, That nothing in this subdivision may be construed to prohibit a County from
83	imposing a hotel occupancy tax.
84	(g) Notwithstanding any other provision of this code to the contrary, a distributee under the
85	provisions of this section may not seek from the Tax Division of the Department of Revenue a
86	refund of revenues or moneys collected by, or remitted to, the Tax Division of the Department of
87	Revenue, nor seek a change in past amounts distributed, or any other retrospective adjustment
88	relating to any amount distributed, to the extent that the moneys in question have been distributed
89	by the Tax Division to another distributee, regardless of whether those distributions were
90	miscalculated, mistaken, erroneous, misdirected, or otherwise inaccurate or incorrect. For
91	purposes of this section, the term "distributee" means any County that has enacted a sales and
92	use tax under this section or as otherwise permitted by law that receives or is authorized to receive
93	a specific distribution of revenues or moneys collected by, or remitted to, the Tax Division of the
94	Department of Revenue pursuant to this section.

NOTE: The purpose of this bill is to create the "County Home Rule Program."
