1 A BILL making a supplementary appropriation of public moneys out of the Treasury from  
 2 the balance of federal moneys remaining unappropriated for the fiscal year ending June 30, 2024,  
 3 to Miscellaneous Boards and Commissions, Public Service Commission – Motor Carrier Division,  
 4 fund 8743, fiscal year 2024, organization 0926, and Miscellaneous Boards and Commissions,  
 5 Public Service Commission – Gas Pipeline Division, fund 8744, fiscal year 2024, organization  
 6 0926, by supplementing and amending the appropriations for the fiscal year ending June 30, 2024.

7 WHEREAS, The Governor has established the availability of federal funds for expenditure  
 8 in the fiscal year ending June 30, 2024, which are hereby appropriated by the terms of this  
 9 supplementary appropriation bill; therefore

*Be it enacted by the Legislature of West Virginia:*
