1 A BILL to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section, 2 designated §18-5-51, relating to safety in public schools; creating the West Virginia 3 Guardian Program: setting out purpose of the program; allowing county school boards to 4 contract for participation in the program; defining terms; setting out the authority of 5 independent contractors participating in the program; providing requirements for 6 participation; providing exclusions from participation; setting forth a limitation of liability; 7 providing exemptions from purchasing requirements; and providing for exclusions from 8 state benefit programs.

Be it enacted by the Legislature of West Virginia:

#### ARTICLE 5. COUNTY BOARD OF EDUCATION.

#### §18-5-51. Public school West Virginia Guardian Program.

- (a) Purpose. County boards of education may contract with an independent contractor who is an honorably discharged veteran, former state trooper, former deputy sheriff, or former federal law-enforcement officer to provide West Virginia Guardian services as that term is defined in this section. The purpose of the contract is to provide public safety and/or security on public school grounds and buildings. Any county board of education may contract with as many independent contractors as the county school board considers necessary.

  (b) Definitions. For purposes of this section, the following words have the following
- "Contract" means an agreement between a county board of education and an independent contractor relating to the procurement of public safety or security services.
- "County school board" means the same as that term is used in §18-5-1 et seq. of this code.
- 13 "Independent contractor" means the same as that term is used in §21-5I-4 of this code.

14	"Public safety or security" means the protection of students, faculty, and staff of a public
15	school from violence, bullying, theft, substance abuse, the sale or use of illegal substances,
16	exposure to weapons, and threats on school grounds.
17	"Former deputy sheriff" means the same as that term is used in §7-14C-1 of this code, but
18	who has retired from service.
19	"Former state trooper" means a state police officer employed pursuant to the provisions
20	of §15-2-1 et seq. of this code, and who has retired pursuant to the provisions of §15-2-27 of this
21	code.
22	"Former federal law-enforcement officer" means a federal law-enforcement officer
23	employed pursuant to the provisions of §15-10-5(b) of this code, who was classified as an 1811
24	Investigator, and who has retired from service.
25	"West Virginia Guardian" means an independent contractor under contract to a county
26	school board for the purposes of providing public safety and/or security on school grounds.
27	Persons contracted to provide these services shall include an honorably discharged veteran, a
28	retired state trooper, or a retired deputy sheriff. A West Virginia Guardian is considered an
29	authorized individual for purposes of the Gun-Free School Zones Act of 1990, 18 U.S.C. §921
30	and §922.
31	(c) Authority. — Notwithstanding the provisions of §61-7-11a of this code or any applicable
32	rule, an independent contractor acting as a West Virginia Guardian may carry a concealed
33	weapon upon meeting all the requirements of this section. A West Virginia Guardian is not law
34	enforcement and may not arrest. They are to provide public safety and/or security to protect life
35	and property as set forth in this section.
36	(d) Requirements for participation. — Prior to entering into a contract with a West Virginia
37	Guardian, the county school board shall require an applicant to provide proof that he or she:
38	(1) Is a citizen of the United States and the state of West Virginia;

39	(2) Has received a high school diploma or a General Educational Development diploma
40	known as a GED;
41	(3) Has met and passed all the requirements for a concealed carry permit as set forth in
42	§61-7-4 of this code;
43	(4) Has completed and passed all the following training courses and/or examinations:
44	(A) The Law Enforcement Professional Standards program at the West Virginia State
45	Police. The cost of this program is to be paid by the independent contractor;
46	(B) A fitness for duty examination that shall include a physical examination, vision
47	examination, a psychiatric examination, and a pre-employment drug screen. The cost of these
48	each shall be paid by the independent contractor; and
49	(C) A firearm and less than lethal use of force course. To maintain firearm proficiency, the
50	independent contractor must complete yearly training in firearm and less than lethal use of force
51	course.
52	(5) Has either been honorably discharged from the United States armed services or is
53	retired from his or her employment as a state trooper or a deputy sheriff;
54	(6) Is current in any obligation, including taxes, to the state of West Virginia;
55	(7) Any other requirements imposed by the county school board which may include, but
56	are not limited to, a pre-employment written examination and a pre-employment polygraph exam.
57	A county school board may also require an independent contractor to carry appropriate liability
58	insurance at his or her expense.
59	(e) Exclusions from participation. — Any of the following shall preclude an independent
60	contractor from participation as a West Virginia Guardian:
61	(1) A dishonorable or less than honorable discharge from the United States armed
62	services;
63	(2) Having not retired from service to the State of West Virginia as a state trooper or a
64	deputy sheriff;

65	(3) Having not retired from service as a federal law-enforcement officer;
66	(4) There is credible evidence of illegal drug use by the independent contractor in the
67	preceding five-year period;
68	(5) A disqualifying criminal offense. These shall include, but are not limited to:
69	(A) Domestic violence as set forth in §61-2-28 of this code;
70	(B) Driving under the influence as set forth in §17C-5-2 of this code;
71	(C) Child abuse as set forth in §61-8D-1 et seq. of this code;
72	(D) Unlawful manufacture, delivery, or possession with intent to deliver any controlled
73	substance as set forth in §60A-4-1 et seq. of this code;
74	(E) Any other misdemeanor or felony conviction deemed exclusionary for contracting with
75	the independent contractor by the county school board.
76	(f) Liability. — A county school board may not be held civilly liable or be criminally
77	prosecuted for any action of a West Virginia Guardian acting within the scope of the duties for
78	which their services were contracted unless the county school board can be shown to be grossly
79	negligent or committed willful misconduct.
80	(g) Miscellaneous. —
81	(1) In contracting for the services set forth in this section, county school boards may not
82	be subject to purchasing requirements set forth in §5A-3-1 et seq. of this code.
83	(2) Nothing in this section requires a county board of education to contract. Participation
84	by a county of board of education is voluntary and subject to the availability of county funds. Any
85	county board of education that opts to participate shall do so at its own expense. The provisions
86	of this section place no obligation for the state to appropriate money for the purposes set forth in
87	this section.
88	(3) As an independent contractor, a West Virginia Guardian is not eligible for participation
89	in the public employee insurance plan, workers' compensation, additional state retirement
