1 A BILL supplementing and amending the appropriations of public moneys out of the Treasury from 2 the balance of moneys remaining as an unappropriated surplus balance in the State Fund, 3 General Revenue, to the Department of Veterans' Assistance, Department of Veterans' 4 Assistance, fund 0456, fiscal year 2024, organization 0613, and Department of Veterans' 5 Assistance, Department of Veterans' Assistance – Veterans' Home, fund 0460, fiscal year 6 2024, organization 0618, by supplementing and amending the appropriations for the fiscal 7 30, 2024, by adding ending June new items of appropriation. year 1 WHEREAS, The Governor submitted the Executive Budget Document to the Legislature 2 on January 10, 2024, containing a statement of the State Fund, General Revenue, setting forth 3 therein the cash balance as of July 1, 2023, and further included the estimate of revenue for the 4 fiscal year 2024, less net appropriation balances forwarded and regular and surplus 5 appropriations for the fiscal year 2024, and further included recommended expirations to the 6 unappropriated surplus balance of the State Fund, General Revenue: and 1 WHEREAS, It appears from the Governor's Statement of the State Fund, General 2 Revenue, there now remains an unappropriated surplus balance in the Treasury which is available for appropriation during the fiscal year ending June 30, 2024; therefore 3
