1 AN ACT finding and declaring certain claims against the state and its agencies to be moral  
2 obligations of the state; and directing the Auditor to issue warrants for the payment thereof.

*Be it enacted by the Legislature of West Virginia:*

**§1. Finding and declaring certain claims against the Department of Health, Bureau for  
Public Health; Department of Administration; Department of Health and Human  
Resources; Department of Military Affairs & Public Safety, Division of Corrections  
and Rehabilitation; Department of Transportation, Division of Highways;  
Department of Health, Office of the Chief Medical Examiner; Department of  
Administration, Office of Technology; and the West Virginia Developmental  
Disabilities Council, to be moral obligations of the state and directing payment  
thereof.**

1 The Legislature has considered the findings of fact and recommendations reported to it  
2 by the Legislative Claims Commission concerning various claims against the state and agencies  
3 thereof and, in respect to each of the following claims, the Legislature adopts those findings of  
4 fact as its own and in respect of the claims herein, the Legislature has independently made  
5 findings of fact and determinations of award and hereby declares it to be the moral obligation of  
6 the state to pay each such claim in the amount specified below and directs the Auditor to issue  
7 warrants for the payment thereof out of any fund appropriated and available for the purpose.
