5	fiscal year 2025, organization 0944, and increasing an existing item of appropriation to the				
6	Department of Human Services, fund 5365, fiscal year 2025, organization 0511, for the				
7	fiscal year ending June 30, 2025.				
8	WHEREAS, The Governor submitted the Executive Budget Document to the Legislature				
9	on February 12, 2025, containing a statement of the State Excess Lottery Revenue Fund, setting				
10	forth therein the cash balance as of July 1, 2024, and further included the estimate of revenue for				
11	the fiscal year 2025, less net appropriation balances forwarded and regular and surplus				
12	appropriations for the fiscal year 2025; and				
1	WHEREAS, It appears from the Governor's Statement of the State Excess Lottery				
2	Revenue Fund, there now remains an unappropriated balance in the State Treasury which is				
3	available for appropriation during the fiscal year ending June 30, 2025; therefore
