#### TWENTIETH DAY

[DELEGATE HANSHAW, MR. SPEAKER, IN THE CHAIR]

The House of Delegates was called to order by the Honorable Roger Hanshaw, Speaker.

Prayer was offered and the House was led in recitation of the Pledge of Allegiance.

H. B. 4801, Relating generally to the banking authority of the State Treasurer's Office,

And reports back a committee substitute therefor, as follows:

Com. Sub. for H. B. 4801 - "A Bill to amend the Code of West Virginia, 1931, as amended, by adding thereto a new section, designated §12-1-1b, and to amend and reenact §12-1-5; §12-1B-5; and §12-1B-7 of said code; all relating generally to the banking authority of the State Treasurer's Office; setting forth prohibited clauses in State Treasurer contracts consistent with general restrictions on other state contracts; providing that the State Treasurer may implement the West Virginia Security for Public Deposits Program; and requiring announcement of the West Virginia Security for Public Deposits Program commencement date on the State Treasurer's website."

And,

H. B. 4837, Clarifying the duty of banks to retain and procure records,

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (S. B. 462) passed.

Delegate Householder moved that the bill take effect from its passage.

On this question, the yeas and nays were taken (**Roll No. 51**), and there were—yeas 93, nays none, absent and not voting 6, with the absent and not voting being as follows:

Absent and Not Voting: Barnhart, Garcia, Hardy, Pinson, Ross and Street.

So, two thirds of the members elected to the House of Delegates having voted in the affirmative, the Speaker declared the bill (S. B. 462) takes effect from its passage.

*Ordered*, That the Clerk of the House communicate to the Senate the action of the House of Delegates.

**S. B. 483**, Amending Corporation Net Income Tax Act; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 52), and there were—yeas 93, nays none, absent and not voting 6, with the absent and not voting being as follows:

Absent and Not Voting: Barnhart, Garcia, Hardy, Pinson, Ross and Street.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (S. B. 483) passed.

Delegate Householder moved that the bill take effect from its passage.

On this question, the yeas and nays were taken (**Roll No. 53**), and there were—yeas 93, nays none, absent and not voting 6, with the absent and not voting being as follows:

Absent and Not Voting: Barnhart, Garcia, Hardy, Pinson, Ross and Street.

So, two thirds of the members elected to the House of Delegates having voted in the affirmative, the Speaker declared the bill (S. B. 483) takes effect from its passage.

*Ordered*, That the Clerk of the House communicate to the Senate the action of the House of Delegates.

**H. B. 4697**, Add protections for WV residents who reside out of state for certain time periods from non-renewal of licenses and registration; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 54), and there were—yeas 93, nays none, absent and not voting 6, with the absent and not voting being as follows:

Absent and Not Voting: Barnhart, Garcia, Hardy, Pinson, Ross and Street.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 4697) passed.

*Ordered*, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

**Com. Sub. for H. B. 4764**, Provide one trip temporary vehicle permits to be purchased and printed online; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 55), and there were—yeas 93, nays none, absent and not voting 6, with the absent and not voting being as follows:

Absent and Not Voting: Barnhart, Garcia, Hardy, Pinson, Ross and Street.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4764) passed.

*Ordered*, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

**Com. Sub. for H. B. 4766**, Require Division of Highways to place signage up 30 days prior to road closure; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 56), and there were—yeas 93, nays none, absent and not voting 6, with the absent and not voting being as follows:

Absent and Not Voting: Barnhart, Garcia, Hardy, Pinson, Ross and Street.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4766) passed.

*Ordered*, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

**H. B. 4783**, Relating to the practice of optometry; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 57), and there were—yeas 91, nays 2, absent and not voting 6, with the nays and the absent and not voting being as follows:

Nays: Anderson and Jennings.

Absent and Not Voting: Barnhart, Garcia, Hardy, Pinson, Ross and Street.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 4783) passed.

On motion of Delegate Summers, the title of the bill was amended to read as follows:

**H. B. 4783** - "A Bill to amend and reenact §30-8-3, §30-8-6 and §30-8-9 of the Code of West Virginia, 1931, as amended, and to amend and reenact §30-8A-1 of said code; all relating to the practice of optometry; defining terms; removing obsolete areas of the code; updating contract provisions; and permitting a licensee to perform certain procedures".

*Ordered*, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

**Com. Sub. for H. B. 4908**, Relating to permitting the state agencies to contract with the West Virginia public health Institute; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 58), and there were—yeas 92, nays 1, absent and not voting 6, with the nays and the absent and not voting being as follows:

Nays: Pushkin.

Absent and Not Voting: Barnhart, Garcia, Hardy, Pinson, Ross and Street.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4908) passed.

Delegate Householder moved that the bill take effect from its passage.

On this question, the yeas and nays were taken **(Roll No. 59)**, and there were—yeas 93, nays none, absent and not voting 6, with the absent and not voting being as follows:

Absent and Not Voting: Barnhart, Garcia, Hardy, Pinson, Ross and Street.

So, two thirds of the members elected to the House of Delegates having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4908) takes effect from its passage.

*Ordered*, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

#### **Second Reading**

**Com. Sub. for H. B. 4017**, To modify certain election laws, early voting laws, and absentee voting laws; on second reading, coming up in regular order, was read a second time.

On motion of Delegate Fast, the bill was amended on page 5, section 10, line 92, by deleting all of subsection (m) in its entirety and inserting in lieu thereof the following:

"(m) Any person who intentionally coerces or offers payment in exchange for a person to register to vote is guilty of a misdemeanor and, upon conviction thereof, shall be fined not more than \$1,000, or confined in jail for not more than one year, or both fined and confined."

On page 12, section 32, line 5, immediately following the word "for", by striking "an unlawful completed registration application from any one person" and inserting in lieu thereof "a person to register to vote".

And,

On page 12, section 32, line 15, immediately following the word "for", by striking "an unlawful completed registration application from any one person" and inserting in lieu thereof "a person to register to vote".

The bill was then ordered to engrossment and third reading.

**Com. Sub. for H. B. 4350**, Relating to appointment of candidates after filing period; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.

**H. B. 4434**, Relating to restrictions on use or sale of motor vehicles based on power source; on second reading, coming up in regular order, was read a second time.

On motion of Delegates Linville and Howell, the bill was amended by deleting everything after the enacting clause and inserting in lieu thereof the following:

### "ARTICLE 14. PROHIBITED GOVERNMENTAL ACTIONS REGARDING SALE AND USE OF MOTOR VEHICLES BASED ON POWER SOURCE.

#### §17-14-1. Definition.

'Motor vehicle' means a self-propelled device designed to transport persons or property from one place to another, and includes, for purposes of this article, farm tractors and implements as defined in §17A-1-1(g) & (q).

#### §17-14-2. Prohibitions based on energy source.

- a) No state agency, nor any political subdivision of this state, may restrict the use or sale of motor vehicles based on the energy source used to power the motor vehicle, including use for propulsion or use for powering other functions of the motor vehicle.
- (b) This subsection does not affect any policy established by a state agency, nor by any political subdivision of this state, related to the purchase of motor vehicles for the use of the state agency or political subdivision."

The bill was then ordered to engrossment and third reading.

**H. B. 4855**, Require Division of Purchasing to write contracts in an unbiased manner; on second reading, coming up in regular order, was reported by the Clerk.

At the request of Delegate Householder, and by unanimous consent, the bill was postponed one day.

**H. B. 4860**, Providing that a general education teacher may not be responsible for accommodation logs; on second reading, coming up in regular order, was read a second time.

On motion of Delegate E. Pritt, the bill was amended on page two, line forty-one, by inserting the word "daily" before "accommodation."

And,

On page two, line forty-one after "accommodation logs.", by inserting the following sentence after the period: "The general education teacher shall only be responsible for acknowledging, at the end of each grading period, that each accommodation as required by the IEP has been met."

The bill was then ordered to engrossment and third reading.

**H. B. 4957**, Relating generally to lobbying rules; on second reading, coming up in regular order, was reported by the Clerk.

At the request of Delegate Householder, and by unanimous consent, the bill was postponed one day.

**H. B. 4976**, Providing the contact information of the Inspector General on the agencies and boards websites of the executive departments; on second reading, coming up in regular order, was read a second time.

An amendment was recommended by the Committee on Government Organization, and adopted, on page 1, by striking the article heading and inserting in lieu thereof a new article heading, to read as follows:

#### "ARTICLE 13. OFFICE OF THE INSPECTOR GENERAL."

And,

On page 3, section 15A-13-1, line 73, after the word "posted" by inserting the words "in any physical office space, when applicable and".

The bill was then ordered to engrossment and third reading.

#### First Reading

- **Com. Sub. for H. B. 4376**, Relating to surgical smoke evacuation; on first reading, coming up in regular order, was read a first time and ordered to second reading.
- **H. B. 4776**, Relating to adding elementary schools into school disciplinary measures; on first reading, coming up in regular order, was read a first time and ordered to second reading.
- **H. B. 4777**, Allow staff members in public schools to eat lunch for free if there is food left over after every student has been fed; on first reading, coming up in regular order, was reported by the Clerk.

At the request of Delegate Householder, and by unanimous consent, the bill was postponed one day.

- **H. B. 4817**, Relating to updating the practice of nursing; on first reading, coming up in regular order, was read a first time and ordered to second reading.
- **Com. Sub. for H. B. 4830**, To address the professional development of teachers; on first reading, coming up in regular order, was read a first time and ordered to second reading.
- **H. B. 4832**, Relating to state superintendent's reports regarding the finances of school districts; on first reading, coming up in regular order, was read a first time and ordered to second reading.
- **H. B. 4838**, Require county boards of education to provide long-term substitute teachers, upon hiring, with certain information; on first reading, coming up in regular order, was read a first time and ordered to second reading.
