The House of Delegates was called to order by the Honorable Roger Hanshaw, Speaker.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 4933) passed.

Delegate Householder moved that the bill take effect July 1, 2024.

On this question, the yeas and nays were taken (**Roll No. 111**), and there were—yeas 94, nays none, absent and not voting 6, with the absent and not voting being as follows:

H. B. 5056, Relating to substitute service personnel positions; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 112), and there were—yeas 95, nays none, absent and not voting 5, with the absent and not voting being as follows:

Absent and Not Voting: Dillon, Moore, Nestor, Ridenour and Ross.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 5056) passed.

H. B. 5153, Relating to revising, updating and streamlining the requirements governing the West Virginia Science, Technology, Engineering, and Mathematics Scholarship; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 113), and there were—yeas 96, nays none, absent and not voting 4, with the absent and not voting being as follows:

Absent and Not Voting: Dillon, Moore, Nestor and Ridenour.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (H. B. 5153) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 5158, Relating to making technical corrections to the special education code; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 114), and there were—yeas 96, nays none, absent and not voting 4, with the absent and not voting being as follows:

Absent and Not Voting: Dillon, Moore, Nestor and Ridenour.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 5158) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 5179, Relating to the creation of "Jaycie's Law."; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 115), and there were—yeas 96, nays none, absent and not voting 4, with the absent and not voting being as follows:

Absent and Not Voting: Dillon, Moore, Nestor and Ridenour.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 5179) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 5200, Requiring that school counselors serving students in preschool through the 12th grade participate in the School Counselors Conference at least once every two years; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 116), and there were—yeas 79, nays 17, absent and not voting 4, with the nays and the absent and not voting being as follows:

Nays: Barnhart, Burkhammer, Coop-Gonzalez, Crouse, Espinosa, Hardy, Hite, Holstein, Kump, Lewis, Linville, Pinson, Riley, Summers, Ward, Winzenreid and Young.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 5200) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Com. Sub. for H. B. 5248, Relating to the regulation of behavioral health centers; on third reading, coming up in regular order, was read a third time.

The question being on the passage of the bill, the yeas and nays were taken (Roll No. 117), and there were—yeas 96, nays none, absent and not voting 4, with the absent and not voting being as follows:

Absent and Not Voting: Dillon, Moore, Nestor and Ridenour.

So, a majority of the members present having voted in the affirmative, the Speaker declared the bill (Com. Sub. for H. B. 5248) passed.

Ordered, That the Clerk of the House communicate to the Senate the action of the House of Delegates and request concurrence therein.

Second Reading

Com. Sub. for H. B. 4320, Relating to access for minor children's medical records; on second reading, coming up in regular order, was read a second time.

On motion of Delegates Summers and Burkhammer, the bill was amended on page 1, by striking everything after the enacting clause and inserting in lieu thereof the following:

"ARTICLE 29. HEALTH CARE RECORDS.

§16-29-1. Copies of health care records to be furnished to patients.

(a) Any licensed, certified or registered health care provider so licensed, certified or registered under the laws of this state shall, upon the written request of a patient, his or her personal representative, as defined by the Health Insurance Portability and Accountability Act of 1996 (HIPAA), as amended, and any rules promulgated pursuant to the act, and his or her authorized agent or authorized representative, within no more than thirty days from the receipt of the request, furnish a copy in the form of a paper copy or, if requested and if the provider routinely stores

records electronically and has the ability to so provide, a copy in an electronic format including, but not limited to, a downloadable format through a secure web portal, a copy saved upon a computer disc, an electronically mailed copy or a copy saved upon a portable memory device of all or a portion of the patient's record to the patient, his or her personal representative, or authorized agent or authorized representative subject to the following exceptions:

- (1) unless, in the case of a patient receiving mental health treatment, for psychiatric or psychological problems, a summary of the record shall be made available to the patient, personal representative, or his or her authorized agent or authorized representative following termination of the treatment. program.
- (2) The furnishing of a copy, as requested, of the reports of x-ray examinations, electrocardiograms and other diagnostic procedures shall be deemed to comply with the provisions of this article.
- (b) Nothing in this article shall be construed to require a health care provider responsible for diagnosis, treatment or administering health care services in the case of minors for birth control, prenatal care, drug rehabilitation or related services or venereal disease according to any provision of this code, to release patient records of such diagnosis, treatment or provision of health care as aforesaid to a parent or guardian, without prior written consent therefor from the patient, nor shall anything in this article be construed to apply to persons regulated under the provisions of chapter eighteen of this code or the rules and regulations established thereunder.
- (c) This article does not apply to records subpoenaed or otherwise requested through court process, except for the fee provisions in §16-29-2, which do apply to subpoenaed records.
- (d) (c) The provisions of this article may be enforced by a patient, personal representative, authorized agent or authorized representative. and any A health care provider found to be in violation of this article shall pay any attorney fees and costs, including court costs incurred in the course of such enforcement.
- (e) Nothing in this article shall be construed to apply to health care records maintained by health care providers governed by the AIDS-related Medical Testing and Records Confidentiality Act under the provisions of article three-c of this chapter.

§16-29-3. Access to minor's records.

- (a) A parent or guardian may not be denied access to the health records of their minor child unless otherwise ordered by a court or pursuant to subsection (b) of this section.
 - (b) A parent is not permitted to access the heath records of that parent's minor child if:
 - (1) The child has graduated high school or equivalate;
 - (2) The child is emancipated; or
 - (3) The child is married.
- (c) Except as provided in subsection (b) of this section, no release, authorization, nor any form of permission from or by the minor child shall be required or requested as a prerequisite for the parent or legal guardian to obtain the medical records."

The bill was then ordered to engrossment and third reading.

Com. Sub. for H. B. 4704, Creating Infrastructure Ready Jurisdictions; on second reading, coming up in regular order, was read a second time.

At the request of Delegate Householder, and by unanimous consent, the bill was advanced to third reading with the right to amend, and the rule was suspended to permit the offering and consideration of amendments on that reading.

- **Com. Sub. for H. B. 4885**, Relating to blocking roadways; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.
- **Com. Sub. for H. B. 5054**, Relating to the licensure of birthing centers; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.
- **Com. Sub. for H. B. 5057**, To raise the threshold for nominal referral fees from \$25 to \$100; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.
- **H. B. 5064**, Relating to obtaining title to abandoned or junked motor vehicles abandoned on the property or place of business of an automobile dealer; on second reading, coming up in regular order, was read a second time and ordered to engrossment and third reading.
- **Com. Sub. for H. B. 5083**, Create mechanism for towing companies in WV to quickly access owner information; on second reading, coming up in regular order, was read a second time.

Delegate Brooks moved to amend the bill on page 2, section 7, line 30, immediately following the word "services" by inserting the following:

", which are regulated the Public Service Commission,".

Whereupon, Delegate Brooks asked and obtained unanimous consent to reform the wording of the amendment as follows:

", which are regulated by the Public Service Commission,".

The question being on the adoption of the amendment, the same was put and the amendment was adopted.

The bill was then ordered to engrossment and third reading.

H. B. 5252, Requiring certain minimum experience for the director or coordinator of services class title involving school transportation; on second reading, coming up in regular order, was read a second time.

On motion of Delegates Toney and Foster, the bill was amended on page 9, section 8, line 201, after the word "an", by striking the word "apprentice";

And,

On page 9, section 8, line 205, after the word "employed", by striking the words "at the apprentice level";

And,

On page 10, section 8, lines 230-231, after the word "employed", by striking the words "at the apprentice level";

And,

On page 10, section 8, lines 239-240, by striking out the definition for "key punch operator" in its entirety.

The bill was then ordered to engrossment and third reading.
