

## *The Greater Wheeling Coalition for the Homeless*



These clients are part of a special needs population with extremely low income who often experience severe barriers to their ability to secure and maintain safe and affordable housing. ## *Wayne County Habitat for Humanity*

The homeowner said the house was a “dream come true” and that her “home was really built with love by Habitat volunteers!”
