The Legislative Rule-Making Review Committee, met in the Senate Judiciary Committee Room at 10:00 a.m. on Tuesday, November 18, 2014. The meeting was called to order by Senator Snyder, and a silent roll call was taken, as reflected above.

Delegate Poore moved that the Department of Agriculture, $Industrial\ Hemp$, 61CSR29, withdraw the rule. The motion was adopted.

Debra Graham, Chief Counsel, explained her abstract on the rule proposed by the **Department of Agriculture**, **Equine Rescue Facilities**, **61CSR32**.

Tinia Creamer, Heart of Phoenix Horse Rescue, addressed the Committee and responded to guestions.

The Chair announced that the rule would be moved to the foot of the agenda.

Senator Miller moved to modify the rule by adding the following language: "3.1 Conservation Districts shall provide recommendations to the State Conservation Committee on local resource concerns, needed conservation practices, financial assistance rates and other local priority needs; 3.2 The State Conservation Committee shall consider the Conservation Districts' recommendations when developing the annual program criteria; and 3.2a Conservation Districts shall use the State Conservation Committee's approved practice list to generate and submit a local priority list to the West Virginia Conservation Agency for approval prior to the start of the program year." Counsel, stated that the Committee agreed to the modification.

Delegate Poore moved the proposed rule be approved as modified. The motion was adopted.
